does not work, why does the state continue to use it?

A. It apparently works well under some conditions. We just have not had the exact conditions necessary in the past couple of years. If it rains before a snow event, then most of the pretreatment will be washed off the highway. However, if we have an extremely dry and cold snow and the air temperatures are well below 20 degrees, it also does not seem to have much of an impact. During last year's snow and the one storm this year, it was so cold that the pretreatment and the salt could not melt fast to have a significant impact on the ice that was on the highways from being packed down by the drivers.

Q. Were there any issues with the snow removal this time?

A While snow removal can always be an issue, I think our employees handled it very well. However, any time you have extremely low temperatures immediately after a snowfall, it means ice will form on the highway and this time was no exception. Also, once ice forms, salt will not melt the snow until the temperature increases above 20 degrees. What really did help was all the sunshine for the next few days following the snowfall. Even though the air temperature is well below freezing, the dark road surface heats with the sunshine, helping to melt the ice. Q. What other precau-

tions are taken by the Road **Department?**

The Road Department was prepared and began salting and scraping as soon as the snow began. This contin-

for on a daily basis to monitor if your teen is depressed, anxious, and could be abusing substances. Look for things like if they are eating too much or too little, sleeping too much or too little or if you see a significant drop in their grades. If they do not have as much enjoyment in normally enjoyable activities or if they have sudden concentration problems, start asking questions. If they are complaining of body aches (headaches, backaches, stomachaches, etc.) that do not have a medical basis after being checked by a physician or are more irritable than normal, then start watching for other clues. It is not normal for a teen to become socially iso-

These are all warning signs. If you see even one of these symptoms - act and get your teen evaluated. Too many parents dismissed these warning signs or were too busy to notice, and their teen ended up in trouble. If your check engine light goes on in your car, you don't keep driving it. These symptoms are the closest you are going to get to your child's "service your teen" light. It is better to be safe than sorry, so act.

If your child does come home under the influence and does not need to go to the hospital, do not take this time to discuss what they did, why they did it, and the consequences that are going to come from it. You cannot be rational with irrational people. Let them sleep it off and discuss it later the next day. The additional time might help you to gather your thoughts and determine the appropriate consequences.
