on 75 counts of dispensing count conviction. prescriptions to Mike Gowder without a legitimate medical purpose, and Mike Gowder was found guilty on 75 counts of aiding and abetting those charges

At the same time, the jury convicted Mike Gowder of 27 counts of acquiring controlled substances by fraud, and jurors found Heaton guilty of aiding and abetting those 27 counts.

Additionally, Heaton was found guilty on 27 counts of dispensing prescriptions without a legitimate medical purpose to two other patients.

All told, Gowder will be sentenced based on 102 counts against him, and Heaton is facing sentencing on a 129-

Originally confronted with dozens of federal charges as a co-defendant in the case, David Gowder pleaded guilty before Judge Story in March 2019 to a single count of prescribing oxycodone without a legitimate medical purpose.

His single count comes with a maximum sentence of 20 years in prison and a fine of up to \$1 million, though Assistant U.S. Attorney William McKinnon said last year the prosecution may recommend a downward adjustment of that

David Gowder was first arrested for prescription fraud in April 2015 in Fannin County. He was arrested

again in February 2016 by the Union County Sheriff's Office. as were Mike Gowder and James Heaton, in connection with other prescription drug Regarding the state's

outstanding charges against the three men, which were brought prior to the April 2018 federal indictment, Enotah Judicial Circuit District Attorney Jeff Langley said he would make a decision about moving forward with local charges after the federal sentencing.

The Gowders and Heaton initially pleaded not guilty to both their state and federal charges, and all three men have remained free on bond while awaiting sentencing.

toward the advancements and looking forward to the year."

Added McGraw, "Our main goal for this year is to keep the focus on the fight against cancer, because we are going into our 26th year. Some folks are getting older and some folks get tired, just like with any organization, but cancer is still on the forefront of most everybody's families, their issues with workplace absences and those kinds of things."

Recent innovations in cancer treatments have helped increase the life expectancy of many cancer patients, thanks in large part to the fundraising efforts of local groups like Union County Relay For Life.

We have had wonderful

advancements in the last few years, and people are living longer and living better," McGraw said. "I think the biggest thing for us is to encourage our survivors and support them with what they had to go through, because it takes a lot out of them.
"We are just going to

direction, and Cox noted their continued suspicious behavior inside the car, Dyer said.

The vehicle, a silver Infiniti, did not match the description of the vehicle they were looking for – a Hyundai – but Cox decided to pull the car over based on her observations of suspicious activity, Dyer

She conducted the traffic stop up on Russell Scenic Highway and Ford Mountain Road," Dyer said. "When she ran the driver's license and dispatch came back with the last name Diaz, I asked dispatch about the first name. They came back and said Reny, and we all went en route to her from town.'

The traffic stop occurred several miles outside Blairsville, though Cox was able to secure the men in their vehicle until help could arrive.

"We took him into custody without incident. Now, we're just waiting on Florida to come pick him up," Dyer said, noting that Diaz had been transported to Union County Jail to await extradition.

Thomas Richard Nickerson, 21, of Murphy, North Carolina, was the driver of the silver Infiniti, and he was also arrested at the scene and charged with failure to maintain insurance and driving with an expired tag, Dyer said.

The connection between Nickerson and Diaz was unknown at press time, as were details of Diaz' alleged crime of armed robbery in Florida.
