her heels, Osborn said.

As it turned out, the suspect did gain entry into the woman's basement, only to be scared into the woods upon the swift arrival of the Union County Sheriff's Office, though he left behind him a pickax lodged in the interior basement door leading to the main area of the house.

As they worked to clear the scene, they saw a car parked on private property about 50 yards from the house that appeared to have been driven recently, as it was not frosted over in the freezing morning temperatures, Osborn said.

The abandoned vehicle belonged to neither the owner of the property on which it was parked nor the 91-yearold resident, so the deputies impounded the car as potential evidence in the burglary. Contained within the vehicle were a pry bar and gloves, Osborn said.

Later that morning, the Sheriff's Office received a

call from the vehicle's owner, Gregory Bryant, wondering why his car had been towed.

Detectives asked him to come in for questioning, and Bryant attempted to explain how his vehicle came to be in that location at that time of the morning when he lived over 10 miles away, Osborn said.

Through the course of Deputies set up a their investigation, Osborn said perimeter around the home. they determined that Bryant's story contained multiple inconsistencies, and he was arrested for the crime.

Bryant, 33, of Union County, has been charged with first degree burglary, exploitation and intimidation of a disabled adult, elder person or resident, possession of tools for the commission of a crime, and criminal trespass.
