over a portion of the money from the sale of the Arby's lot and transferring to the city the parking lot and greenspace parcels behind City Hall to settle the remaining debt.

After turning over these parcels, the DDA will use funds remaining from the Arby's sale to go toward construction of the proposed 175-space parking lot and public restrooms, plus the development of the greenspace, all for the betterment of the downtown area.

"The investment in our community is appreciated, and the funds from the sale will allow us to move forward with enhancing the parking in downtown," DDA Program Manager Darren Harper said.

DDA Board Chair Paul Thompson said the Arby's deal was a win for all parties involved, including the community.

"We feel like we've accomplished the goal that we set to get the funds back for the city – that's our job – and to bring progress to town, so I think we've done that," Thompson said. "I'm really looking forward to getting the parking lot and restrooms under construction and underway.

'And I'd really like to see that take place fairly quick, because I think that would add a whole lot to downtown, having something like that that people can use.'

Union County Development Authority Executive Director Mitch Griggs has been actively recruiting Arby's for years, with the current deal originating in a trip Griggs took to a trade show in fall 2018. There, he successfully recruited Arby's developer Mike Aldredge to

"This is fantastic on a lot of fronts," Griggs said after the deal closed. "No. 1, it's a new business, and that's always a good thing – it's always good to bring in a national commercial enterprise."

Arby's will add to the local tax base in the form of property

conducting the screenings, and many international airlines have announced disrupted services to and from China.

The first case of 2019n CoV in the U.S. was diagnosed on Jan. 21 in Washington state, and a second case followed on Jan. 23 in Illinois. As of press time, the

CDC was reporting a total of seven cases in four states in the U.S., including California and Arizona, and 36 states with patients under investigation.

An eighth case was reported in Massachusetts by state health officials on Saturday, Feb. 1.

"The man recently traveled to Wuhan, China, and sought medical care soon after his return to Massachusetts," the Massachusetts Department of Public Health said. "He has been isolated since that time and will continue to remain isolated until cleared by public health officials.

"His few close contacts have been identified and are being monitored for any sign of symptoms.'

By Sunday, Feb. 2, WHO was reporting 14,557 confirmed cases worldwide, with 14,411 of those cases being in China, and only 146 confirmed cases in a total of 23 other countries.

Six major airports are to the virus by press time had all occurred in China but one; a Chinese patient in the Philippines, who had flown in from Wuhan, became the first victim to succumb to the virus outside of mainland China over the weekend.

still many in the mountains.

According to the nonprofit's most recent report, S.A.F.E. served 309 victims of abuse in 2018-2019, including 220 adults and 89 children; provided shelter for 93 victims; answered 469 crisis hotline calls; assisted 36 families with Christmas gifts; served 36 families through the Butterfly House Child Advocacy Center; and helped those in need of assistance pertaining to abuse.

Aiding the group in funding its efforts is the S.A.F.E. Thrift Store at 27 Pinebrook Drive in Blairsville, which last month hosted a "20/20 Sale" on Thursday, Jan. 9, to bring in customers and sell off some of the store's inventory.

The sale worked by offering a deal allowing shoppers to pick out 20 articles of clothing for just \$20.

Holding the 20/20 sale effectively increased the number of customers for the day, who bought clothing items in bulk and assisted the thrift store in controlling its inventory.

The thrift store's new Blairsville location has seen more foot traffic and also more donations since the relocation last year.

"When we first moved the store, it took a hit, because we had to get settled and get everything running the way we wanted it to," Cousin said. "But we saw a significant increase of people coming through the store, and I think that has a little to do with the economy, but also the location and media we have on it.

"What we get the most of are donations. We get tons of donations, and sometimes

more than we can use." S.A.F.E.'s mission statement reads: "To provide support, advocacy, and emergency shelter for victims of domestic abuse, child abuse and sexual abuse, regardless of gender, and to heighten community awareness of such abuse in Towns and Union

The S.A.F.E. organization is governed by a volunteer Board of Directors and is funded by state, federal and private grants, according to SAFEservices.org.
