## Lady Panthers split two Region matches despite 17 combined goals

The eighth-ranked Lady Panthers (1-2-1, 1-1) recorded their first win of 2020 on Friday night with a 9-0 rout at Monticello. Earlier in the week, Union County dropped an 8-6 shootout to Rabun County after rallying for a 5-4 advantage in the second half.

Sophomore Melia Whitener and senior Desaray Patterson each recorded a brace for the Lady Panthers. Still, it was not enough as they fell to Rabun for the first time in 10 meetings (2010).

Trailing 1-0 early, freshman Italia Salazar evened the score with a goal in the sixth minute. The Lady Wildcats answered with a free-kick and a penalty-kick goal to take a 3-1 advantage during the 20th

Whitener responded with a goal in the 21st minute, and Patterson answered Rabun's fourth goal with one of her own in the 39th minute to pull within 4-3 at the

Senior Mattison Ruff and Whitener both scored in the 47th minute to open up a 5-4 lead, but Rabun tied it up in the 55th minute. Still tied at 5-5 after 66 minutes, the Lady Wildcats scored three goals in eight minutes for an 8-5 advantage.

Patterson picked up her second goal of the evening in the 78th minute to bring the final tally to 8-6.

Patterson struck again for a 2-0 advantage in the 14th minute. Consecutive goals by Ruff in the 33rd minute made it 4-0 -- the final point coming off a Shelby Poling assist.
