Super Chef Showdown a success despite lower turnout

Guests and volunteers joined the Hope House of Union County at First United Methodist Church to celebrate

the Ninth Annual Super Chef over the coronavirus, but the Showdown on Saturday, March event was still a big success.

Attendance was down this year, among both chefs and attendees, likely due to people wanting to avoid public spaces

The Super Chef Showdown is the Hope House's biggest fundraiser of the year, as each year, area leaders and church members become chefs for a day to prepare unique dishes for charity. One hundred percent

of the proceeds from the showdown benefit the Hope House, which is a faith-based organization that "provides assistance with the basic necessities of life to Union County residents, transients and homeless population who are in critical need.

Following an interview process, Hope House's caseworkers can use donated funds to assist clients with lodging, prescriptions, heating assistance, automobile gasoline, medical treatments, transportation, utility bills and

That's why the Super Chef Showdown is so important as a source of funding for community needs. Hope House Board Treasurer Evelyn Ueltzen said the showdown is a significant event that usually features around 20 chefs and draws in the community in

large numbers.

In years past, the public has come in, paid an admission fee, and gotten to eat of the delicious dishes prepared by the community chefs. This year, it was donations only for people to eat, as they only had 11 chefs, Ueltzen said.

"Usually, we have a line out in the parking lot waiting to come in," Ueltzen said. "Obviously, we don't have that today. We usually have a band, who canceled last night. So, we certainly understand everyone's concerns, but this is our main fundraiser."

Hope House Board members struggled with whether or not to go on with the event, Ueltzen said, though they decided to proceed with the worthy cause for those who were willing to participate especially since people will likely need the help now more than ever in light of the virus.

The public and three judges went around to each group of chefs for tastings. Each chef table had a jug for the public to vote for their favorite dish, and once the judges had a chance to sample each dish, they came together to discuss the top dishes.

There are two categories in the showdown: People's Choice Award and Chef's Choice. The latter is decided by the judges, who are strictly judging on taste and presentation.

For the taste portion of the competition, Third Place went to the Circle of Love at First United Methodist Church for their chocolate bark; Second Place went to the Blairsville Police Department

So, this is our main fundraiser in order to fund giving back to the community.


Also during the event, guests were entered into a raffle for various prizes, and they got the chance to participate in a silent auction.

the elections already scheduled for that date.

"Given these circumstances, I believe it is necessary and prudent to suspend in-person voting in the Presidential Preference Primary, and the local elections associated with them, and resume in-person voting for those elections as part of the already scheduled May 19 General Primary,'

Raffensperger said. The CDC recommends those, including seniors, who are at greater risk from COVID-19 limit their exposure to the virus by keeping space between themselves and others, avoiding crowds, and staying at home during outbreaks in their community.

Dr. Anthony Fauci, the head of the National Institute of Allergy and Infectious Diseases, has likewise identified individuals 65 years old and older as facing increased risk from COVID-19. He explained that older Americans infected with COVID-19 stand a greater
