Former hospital CEO, physicians indicted in federal court

Mike Gowder, Dr. David Gowder and Dr. James Heaton have been brought up on federal charges in the U.S. District Court for the Northern District of Georgia, Gainesville Division.

The three men have been indicted as part of Operation SCOPÉ, "for illegally prescribing and obtaining thousands of doses of prescription pain medications outside the usual course of professional medical practice and for no legitimate medical purpose," per a news release from the U.S. Attorney's Office

A federal grand jury handed up the 212-count

April 4, and the document was unsealed on Friday, April 6. The Gowder brothers

and Dr. Heaton were expected to appear in federal court in Gainesville after press time on Monday, April 9, to be arraigned on the charges.

"These defendants allegedly abused their positions as medical professionals to obtain illegitimately thousands of doses of prescription pain medications and now face serious federal charges," said U.S. Attorney Byung J. "BJay" Pak. "The Department of Justice is committed to fighting the opioid epidemic through the aggressive investigation and prosecution of licensed medical practitioners who abuse their positions of trust to

Robert J. Murphy, Special

Agent in Charge of the DEA Atlanta Field Division, also commented on the indictment.

"Americans rely on healthcare providers, many of whom are medical doctors, to use their training to help patients and to 'do no harm,' said Murphy. "The physicians and the hospital CEO in this case violated the law and betrayed their responsibilities by unlawfully obtaining and dispensing prescription

opioids.

"The moment these individuals decided to engage in this criminal behavior, they became nothing more than traditional drug traffickers. DEA, its law enforcement partners and the U.S. Attorney's

Tallent to retire after leading United **Community Bank for decades**

Under Jimmy Tallent's leadership, a single community bank founded in Blairsville grew to become the third largest Georgia-based bank and a \$12.3 billion holding company with more than 150 banking locations spread across four Southern states.

Now, after a nearly 35year career that began at Union County Bank in 1984, the chief executive officer of United Community Banks Inc. is ready to retire.

"I had two goals in mind that I put in place two years ago," said Tallent. "One is, I wanted to see this company back in a very strong position financially, and we're there.

"Secondly, I wanted to make sure that we had a senior management team in place that can carry this company

forward for well into the future. Honestly, both of those boxes are checked. United is in a great, great place today, so the time is just right."

Tallent will remain in his current position until June 30, at which point he will transition to leading the company's board of directors as chairman.

He will continue to reside in Blairsville and work out of his offices here, though he said that, nowadays, technology has made it easy to work anywhere he may be needed.

"This is where it was birthed, and I'm very proud of that," said Tallent of the company. "It's not so much about being in any one location. We have a videoconferencing system that's used all the time every day." Known as "The Bank

That Service Built," UCBI holds fast to a specific creed that emphasizes the customer-first approach at United Community Banks, and Tallent believes strongly in what he calls the Golden Rule of Banking, "treating our customers the way we would want to be treated."

He has returned to this rule time and again over the

Real life American hero and world-renowned marksman Eric England, 84, passed away on Saturday,

England, a retired Master Sergeant in the U.S. Marine Corps, was considered by many to be the world's greatest marksman, though he embraced his legacy with thoughtful humility.

The Union County native had 98 confirmed combat kills and many more unconfirmed as a scout sniper in Vietnam, thereby saving an untold number of American lives during combat.

In December 2017, the U.S. Marine Corps posted a video interview with England to YouTube titled "A Sniper's Distance."



Pinwheels in place for Child Abuse Awareness Month

Driving around the Downtown Blairsville Square this month, notice the 291 blue pinwheels stuck down in the lawn of the Historic Union

County Courthouse. The pinwheels are a national symbol of child abuse prevention, and each one of the 291 pinwheels represents a child advocated for in 2017 by volunteers with Enotah

These children were abused or neglected in some way, enough to require legal intervention in their best

interests.

Enotah CASA is nonprofit organization with the goal of ensuring that every child has a safe, permanent home. They do this by providing specially trained volunteers known as CASAs,

or Court Appointed Special

of the children in mind, CASA volunteers advocate for the needs of abused and neglected kids in the custody of the Department of Family and Children Services, and throughout lengthy legal processes in the Enotah Judicial Circuit Juvenile

Ninety-two of the 291 children who received help from Enotah CASA volunteers in 2017 were children of Union County, with the remainder coming from either Towns, Fannin or White counties.

The blue pinwheels will be on display in Blairsville through April, and they serve to commemorate April as Child Abuse Prevention
