One of the main goals

of a pair of informational meetings held last week was to give residents of Union and Towns counties chances to provide feedback on what is likely to be the final set of plans for the project.

According to GDOT, the plans will be finalized soon so that property owners can be notified about the right of way process, with the next three years of the project allotted for acquisition of properties along the project corridor.

Public comments become part of the official record of each GDOT project, and in some cases actually cause changes to be made to projects.

Residents interested in leaving public comments, which must be submitted by Thursday, April 20, can view plans for the project by visiting www.dot.ga.gov/ps/public/ publicoutreach.

Look for the "Search Public Outreach" heading about halfway down that webpage, and select either Union or Towns from the "By County" list, then click "Go."

A list of projects will appear – click on the link that says "122900 Young Harris Bypass." From there, residents can see the entire layout of the project, and can leave

Continued discussions of an imminent agreement with Notla Water Authority and an amendment to the city's alcohol ordinance were also prominent topics of conversation during the meeting last Tuesday.

During the February city council meeting, Mayor Conley proposed to the council an agreement between the city and Notla Water Authority concerning commercial property on Pat Haralson Drive.

Through this agreement, Notla Water Authority would provide water and sewer to the commercial property at a discounted rate to the city, increasing the chances of the

Recently, the council learned that, due to an oversight in the city's current alcohol ordinance, a business within the city limits was allowing brown bagging on Sundays.

To prevent such a violation from occurring again, and to keep with conformity with the county's ordinance on the matter, the council voted to include an amendment preventing brown bagging.

Mayor Conley and the

council held a public hearing and second reading of the amendment during the meeting, and the revised ordinance will go into affect immediately.

When first approaching the agreement, Notla's only stipulation for going into a contract with the city was that the city only provide the water and sewer bought from Notla to commercial properties, prohibiting any neighboring residential homes access to the discounted rate and water and sewer hook-up.

Since, Mayor Conley and Attorney Barrett met with the Notla Water Authority Board during its March meeting to further discuss the agreement and outline a contract for the city to discuss, and move forward with the agreement.

However, upon further review of the preliminary agreement, the council found concern with the third item of the agreement, which stated that Notla would increase the price of the water to the city at the same rate reflected in that of increased customer rates.

Essentially, the council was concerned that it left an opening for a change in rate from the discounted price agreed upon for the commercial property.

"Another problem with this is, we can't just go up on one particular customer or customers on Haralson Drive, without it affecting everyone in the system," said Mayor Conley.

To relieve concerns on this item of the agreement, Attorney Barrett agreed to amend the third item to include the word "proportionate" in reference to the rate increases to the city, rather than reflective. In doing so, the rate at which the water is sold to the city will remain at a proportional discounted rate, even when rates increase, and will not affect other water rates within the city.

Attorney Barrett will present the amended agreement to the council during the May council meeting.
