The summit is an opportunity for people and organizations involved in emergency management to gather together for training and to discuss the latest issues. Attending were emergency managers from federal, state,

county, city, and private organizations. Fire Dept. There were also partners such as Nationfrom Union al Weather Service, Red Cross, hospitals, venders, business... the list goes on.

One of the guest speakers was the current administrator of the Federal Emergency Management Agency (FEMA), William B. "Brock" Long.

Mr. Long began his service as the Administrator of the Federal Emergency Management Agency in June 2017. He gave a briefing on many current projects and disasters that have occurred over the last year. Mr. Long stated that he has been busy with these projects but he was also working on reshaping FEMA.

One of the things that he presented was the latest FEMA strategic plan and goals. The three overarching goals stated by Mr. Long were to "Build a Culture of Preparedness; Ready the Nation for Catastrophic Disasters; and to Reduce the Complexity of FEMA". He outlined the way in which he hoped to implement this plan over the next couple of years.

These goals fall in line with our goals and with the motto that we have chosen for Union County Emergency Management which is, "Create and maintain a prepared and resilient community". Mr. Long believes as we do. We believe that it takes everyone working as a team to prepare and sustain ourselves in a disaster.

Emergency management and public safety will be there in a disaster, but our resources are limited. It also takes the prepared citizen to ensure that we will be able to withstand and recover from a disaster. We, as the emergency management, consider the citizens part of the team. something's wrong with you, or him. Prayer, according to the Bible, is far more serious and profound than that. We would have enjoyed know-

ing Nicolas Herman (1614-1691). After years as a soldier, he entered a monastery in Paris. His job? The kitchen. He is known today as Brother Lawrence, and something of his life is captured in the book, The Practice Of The Presence

Of God. His peaceful and joyful demeanor derived from a certain intimacy with God which attracted people. His life reflected this verse: "Rejoice always; pray without ceasing; in everything give thanks; for this is God's will for you in Christ Jesus" (1 Thes. 5:16-18). To him, prayer was not a bowed head, a quiet time, or religious words. He could pray without ceasing because he cultivated an awareness of God's presence

in every moment. Even in the kitchen, taking care of business. It seems that the Brother didn't really see the need for scheduled devotional times in the monastery. He said, "The time of business does not with me differ from the time of prayer; and in the noise and clatter of my kitchen, while several persons are at the same time calling for different things, I possess God in as great tranquility as if I were upon my knees.

This nudges us toward a relational frame of mind. "In Him we live and move and exist" (Acts 17:28). "The Spirit of God dwells in you" (1 Cor. 3:16). Lawrence said, "How can we pray to Him without being with Him? How can we be with Him but in thinking of Him often? And how can we often think of Him but by a holy habit which we should form of it?" When he had to focus on work, he would pray, "O my God since thou art with me, and I must now in obedience to Thy commands apply my mind to these outward things, I beseech Thee to grant me the grace to continue in Thy presence."

## **Alzheimers**

Dear Editor,

In 2007 my parents were in a head-on collision during my grandmother's funeral and my father was killed instantly. I quit my job to take care of my mother who has Alzheimer's. I cared for her for 9 years before moving her into a personal care home. She is now 86 years old. I now volunteer and advocate for the Alzheimer's Association to help bring awareness to this dis-

We need to change the way we think about Alzheimer's disease. Too often Alzheimer's is treated as an aging issue ignoring the fact that someone in the U.S. develops this disease every 65 seconds. Two-thirds of its annual costs are being borne by Medicare and Medicaid.

As one of the 527,000 caregivers in Georgia of someone living with Alzheimer's, I understand the disease's impact and the physical and emotional costs.

Congress has a chance to take decisive action passing the Building Our Largest Dementia (BOLD) Infrastructure for Alzheimer's Act (S. 2076/H.R. 4256). Endorsed by the Alzheimer's Association, BOLD would create an Alzheimer's public health infrastructure across the country

The hemlock trees across north Georgia are dying by the thousands due to infestation by an invasive insect, Hemlock Woolly Adelgid, that was accidentally imported to the eastern U. S. in the 1950s. To preserve some of these magnificent trees on our public lands in Rabun County, Save Georgia's Hemlocks and the U. S. Forest Service have planned a hemlock treatment project for Saturday, May 12.

## A Shivaree

A "shivaree" was a big part of most marriage celebrations during my parents and grandparents younger years. I think today we are all too

busy for this type of activity. Don't get me wrong, I enjoy participating in the social media we find on the internet. However, the social media we use via



our computers cannot really forge long lasting friendships like we develop when we rub elbows with one another. To me the social networks are tools I can use to keep up with friends.

A shivaree was a custom during my grandfather's time. The event was held after a marriage ceremony. Remember, there was no such thing as a trip to the beach or mountains for one's honeymoon. After my grandparents married they were allowed to live in "the weaning off house" until they could afford to get a place of their own. After their marriage ceremony Papa and Granny knew that the "shivaree" was coming to their place.

After dark Papa heard the "shivaree" coming. About 15-20 of their friends and relatives walked down the lane to their house. The group of people was all singing a song. These friends of Papa and Granny built up a large fire in the front yard of the "weaning off house". Some of the group kept up the singing while the rest of the group roasted some chickens and made coffee. Then about every 15-20 minutes the group would parade around the house beating on the walls with pots and pans. Every now and then someone from the group would knock on the door to ask about borrowing some sugar or salt. Papa said, "And you had better answer if they knock or things might get rowdy". The "shivaree" would last the entire evening and the group would not go home until dawn the next morning. Papa said his friends were up all night in his front yard and no amount of pleading could convince them to leave.

Papa also participated in some of these chivalries. He remembered one where the group of boys took things a little too far. He said, "We walked around the house beating on the sides with frying pans and singing. We even knocked on the door to ask for some salt. But, we heard nary a peep from inside. So, one of the boys decided we should go in and steal the groom". The group of boys walked into the house and down the hall to the bedroom. They flung open the bedroom door and grabbed up the protesting groom and carried him outside. The group of boys walked around the

#### The History of the American Tree Farm System

What is Certification? Forest certification is the certification of land management practices

to a standard of sustamability. A written certification is issued by an independent third-party that attests to the sustainable management of a working forest.



Forest certification gives consumers assurance that products they purchase originate from sustainably managed forests that protect economic. social and environmental benefits. A forest's certification is shown exclusively through listing in the ATFS Verification Database.

The American Tree Farm System certifies forest management to eight standards of sustain-

What is Third-Party Certification? Third party certification is the auditing of a forest certification system by an outside, accredited certification body.

Each American Tree Farm System Region, Independently Management Group program, and individual third-party certificate holder is required to undergo an audit by a certification body accredited by an International Accredita-tion Forum (IAF) member organization such as the American National Accreditation Board (ANAB) or the Standards Council of Canada (SCC). Audit teams from these certification bodies will be examining on the ground conformance to the AFF Standards of Sustainability.

What is PEFC? The American Tree Farm System has been endorsed by the Programme for the Endorsement of Forest Certification systems (PEFC) since 2008. PEFC is an independent, non-profit, non-governmental organization, founded in 1999 which promotes sustainably managed forests through independent third-party certification. PEFC provides an assurance mechanism to purchasers of wood and paper products that they are promoting the sustainable management of forests.

PEFC is a global umbrella organization for the assessment of and mutual recognition of forest certification systems in various countries around the world. There are 25 PEFC endorsed forest certification systems covering more than 200 million hectares of certified forests, making PEFC the world's largest forest certification system. Forest certification systems must go through a rigorous assessment process involving public consultation and the use of independent assessors to be considered for endorsement. Final endorsement is subject to a vote taken by
