with GDOT Right of Way purchasers who will need part of our new county property for the widening of Highway 515.

Q. Is the Highway 515 widening project from Blairsville to Young Harris really needed?

A. This project came down from GDOT in Atlanta and is not a part of the county decision making process. We are just trying to be assured that we get as good an access as possible to our property. However, with the continued

increase in traffic along this highway and the number of accidents, this should be a serious safety improvement. Any time a new road is being built it will certainly impact properties, homes and businesses along the highway. I am glad this is an issue that the county does not have to deal with and we appreciate GDOT constantly working to improve our roads and their safety all across the state. We are glad that someone has the vision and expertise to help look out for the transportation future of our area.

the FPAC agencies will ensure that landowners and producers within Sentinel Landscapes have access to the tools and resources they need to keep their land in agriculture and to support the next generation of farmers and private forest landowners. Offering several farm safety net programs, credit and voluntary conservation programs, FSA, NRCS and RMA programs address a variety of farming needs and related conservation issues. This new partnership in Georgia will help the federal and state government agencies involved to work closer together with the private organizations to meet the three primary goals of protecting natural resources, creating, or maintaining habitat for diverse species and enhancing military readiness. Through programs like the Environmental Quality Incentives Program and Conservation Stewardship Program, NRCS helps producers develop a conservation plan and funding to implement con-

servation practices. Meanwhile, the Agricultural Conservation Easement Program enables landowners to protect agricultural lands and wetlands for the long term, which offers an income source while helping them to improve the quality of their land. The Georgia Sentinel Landscape

partners seek to leverage broad goals and shared priorities to ensure the continued viability of important military installations and support the protection of habitat corridors for diverse important species such as the gopher tortoise, red-cockaded woodpecker, and eastern indigo snake. The partnership seeks to protect a core of at least 5,000 acres of important farmlands within the next five years. Another goal calls for the protection of more than 136,000 acres in the Savannah River watershed over the next 20 years. Partners also hope to protect more than 20 additional viable gopher tortoise populations over five years to make it unnecessary to list this species under the Endangered Species Act. Additional partnership goals include increasing public access to outdoor recreational opportunities, improving management practices on private lands, and expanding outreach activities to private landowners within the landscape.

side the home, and substance that your child is already enabusing children can cause considerable disruptions to their parents' work routine. Family problems impact the productivity of employees, and subsequently hurt a company's profitability. It is important for companies to provide information to their employees to help them keep their children drug

Treatment professionals recommend that when discussing substance abuse, kids need to hear from their parents starting at an early age that drug and alcohol use is not condoned in the family. They need to learn from parents about the consequences of substance use and abuse, and they need to be held accountable for their actions. Each parent must find his or her own right way to deliver this message, and sometimes simply saying, "I don't want you to use drugs or alcohol or be in a situation where they are

being used," is enough.

It is also important to help kids know what constitutes a risky situation so that they can avoid potential problems. Parents should help their teen understand that being places without "safe adults" in the vicinity, getting into a vehicle with someone who is impaired, going to a party, or being alone with a non-relative adult could lead to problem situations. Some parents provide their kids with a code word or phrase that can be used if the child finds him or herself in a difficult situation and needs immediate transportation (like at a party or other gathering where drugs or alcohol are be-

When communicating with your child about drug and alcohol use, certain boundaries must be clearly set. Knowing the limits of behavior ahead of time gives kids the "guardrails" they need to be successful in life. But rules are useless if they are not enforced and if there are no real consequences

Most parents work out- the best cure, but if you find gaged in substance abuse, it is time to seek professional help. There are experts available who can help facilitate communication and determine the best next step for your teen. Check with your health insurance provider or the company Employee Assistance Program (EAP) for information on how to access this assistance.

Other sources of help include school counselors, family doctors or pediatricians, faith leaders, community health centers, adolescent prevention and treatment professionals, local anti-drug coalitions, law enforcement agencies, and community re-

source officers. But the best time to find help for a drug abusing child is before the need arises. Be proactive in identifying key resources in your community before the crisis occurs. Community prevention coalitions often have many. Most communities have referral services for a variety of health and human services, including the county health department, hospital referral, free clinic, etc. Your physician or clergy can be great sources of information but are also good re-

sources for referral. It is important to know that there are many websites available, but not all websites provide factual information. Websites provided through U.S. government agencies are well-researched and always provide the most current information.
