public.

Q. Why is GDOT insisting on a concrete median along this commercial area of the Highway 515 expansion?

A. Safety! GDOT is taking into consideration the accident problems they are experiencing in other similar areas, and as they build new sections of highway, they try to apply what they have experienced in other areas to increase safety. This may be frustrating for some businesses as they are used to vehicle patterns as they currently are, which contains a simple center turn lane that anyone can use. The issue we are dealing with in this area is that traffic will be entering this

commercial area with a 55mph speed limit dropping to a 45-mph speed limit. As we all know, when you have a long stretch of 55-mph, many people travel at 65-mph and they will then have to drop their speed drastically as they enter the outskirts of Blairsville. With this being a new business district, which also has the Farmers Market and a future ball field complex the concrete median will help with safety by eliminating people crossing over. So, trying to balance business access with safety is a conflicting situation that GDOT has to deal with and as the county we are trying to help balance this as well.

state lines. A network of monitoring plots established by Forest Stewards enables partners to track the effectiveness of management actions. Consistent, long-term monitoring is essential, since it can take years and multiple treatments—for the full impact of fire in hardwoods to become evident.

The second comprehensive assessment using these data has been completed and will be used to inform planning for future burns and other restoration work. SBR FLN partners include Georgia Blue Ridge Mountains, Great Smoky & Unaka Mountains Northern Escarpment, Central Blue Ridge Escarpment, Nantahala & Balsam Mountains, Southern Blue Ridge Escarpment, South Mountains, New River Headwaters, Network Partners Consortium of Appalachian Fire Managers and Scientists, Forest Stewards, Georgia Department of Natural Resources-State Parks; Wildlife Resources Division, Georgia Forest Watch, Greenville Water Land Trust for the Little Tennessee River, Mountain True National Park Service-Blue Ridge Park-way; Great Smoky Mountains, North Carolina Division of Parks and Recreation, North Carolina Forest Service, North Carolina Wildlife Resources Commission, South Carolina Division of Natural Resources, South Carolina Forestry Commission, South Carolina State Parks, The Nature Conservancy, Towns County Fire Adapted Communities Learning Network, USFS Chattahoochee-Oconee NF; Cherokee NF; Nantahala NF, Pisgah NF, USFS Region 8 Fire & Aviation, USFS— Southern Research Station, and ChestChatt RC&D.

Promoting Ecosystem Resilience and Fire Adapted Communities support the Fire Learning Network together with PERFACT, a cooperative agreement between The Nature Conservancy, the USDA Forest Service, and agencies of the Department of the Interior. This FLN has helped build the foundation of the Joint Fire Science Program's Consortium of Appalachian Fire Managers and Scientists, and continues to play a key role in providing opportunities for networking among scientists, managers and practitioners. This accelerates transfer of knowledge and feedback that supports adaptive management.

Well-attended workshops, (they cut this year's meeting attendance (for the second time) off at 100 with a waiting list) collaborative projects, and tools shared by online seminar and other means have helped the SBR FLN build strong working partnerships. These in turn support the steady growth of the network, most recently with the addition of the Georgia Blue Ridge Mountains landscape. This landscape brings a new dimension to the SBR FLN, as it includes Towns County, a member of the Fire Adapted Communities (FAC) Learning Network. would require 877 acres of land costing app. 439 billion dollars to install plus land cost. Solar panels require sunlight so all energy would have to be used during daylight hours.

These areas where solar panels are placed are called solar farms for a reason, they are placed on farm land. Taking 877 acres of farm land out of food production will result in less food for human consumption. To keep land in food production, the solar panels must be placed somewhere else.

Since the Chattahoochee National Forest which makes up app. 50% of Union County and is not being managed to produce any products the solution should be clear. Cut the 877 acres (.9% of the forest) and place the solar panels in these areas. These solar forests will allow the farm land to remain productive while providing the acres need for the desired solar panels.

As the cost of solar panels goes down and the en-

ergy needs go up, we can look forward to having more solar forests all over the mountains. Since the panels are only productive for twenty to twentyfive years and will have to be replaced, it will still take a long time to cover the mountains.

minor, the study did not find that marijuana was harmless to young people. Far from it.

In fact, the study -- a meta-analysis that looked at data from 69 previous studies, found that adolescents who are chronic marijuana users scored much lower on executive functions, including memory, learning and other cognitive tests than non-users did.

This issue is forefront for every state that considers legalizing weed for recreational use.

Theodore Petti, professor of psychiatry at Rutgers-Robert Wood Johnson Medical School, cautioned the research. While he acknowledged that it is possible that a 72-hour break from marijuana could lessen some of the short-term cognitive effects of marijuana, he said that wasn't the point. The drug, he said, poses detrimental effects.

He said the simple reason is that young people's brains are still developing (the brain doesn't fully develop until age 25), and therefore, it remains vulnerable to marijuana.

"It increases dropping out in high school, decreases motivation and increases the likelihood on becoming dependent on marijuana," Petti said.

A 2014 study also cautioned the use of marijuana at early ages, saying that it "might have lasting consequences on cognition," increasing the risk of mental disorders.

Petti also noted that the study merely looked at previous studies of the effects of heavy marijuana use rather than a live study with actual study participants.
