Holding a cell phone or iPod while driving; writing, reading or sending messages while driving; reaching for a device if it requires the driver to leave a seated, driving position; or watching movies or anything else on any device, except a GPS device.

Darren Harper, program manager of the Blairsville Downtown Development Authority, reported that the DDA had met earlier that day and approved a contract for the sale of one of the old Haralson Property parcels. Construction, he said, will begin very soon.

There are contracts pending on two of the three remaining Haralson parcels as well, he said.

Harper also stated that the Spring Arts, Crafts & Music Festival held on Memorial Day

vendors and booths, there were a few glitches this year, but Harper said they learned some valuable lessons to carry through to next year. John Hamler, manager of the Blairsville Municipal

Airport, said he'd had five or six people who are new Union County residents stop in to inquire about keeping their airplanes at the airport. Hamler also reported

that Air Methods, the local life flight helicopter service, will be renting additional hangar space for a new helicopter, and Blairsville Mayor Jim Conley asked if this was the new helicopter that can fly in bad weather. Hamler said yes.

The hangar waiting list is up to 50-plus people, and

Hamler suggested that the city council give some thought to building more hangars to serve as additional revenue streams at

the airport.

With the upcoming addition of new fuel systems at the airport, Hamler foresees fuel sales approaching the neighborhood of \$1 million per year in the next two to three years.

The council approved the purchase of a Kubota zero-turn mower from Nelson Tractor for \$12,157.28 to be used at the airport.

It will reduce mowing time significantly because it can mow around the runway and taxiway lights quicker and easier than the old mower, giving staff more time to spend with customers.

Also approved in the council meeting was a contract with the Georgia Department of Transportation to install the

Jet-A fuel farm at the airport.

The city is benefiting greatly from its partnerships on the project, as the total state and federal contribution under this contract is \$113,787.74. Out of a total project cost of \$148,388.33, the city will only have to come up with \$34,600.59.

Recently, City Accounting Clerk Joan Mannheim discovered that the Blue Ridge Mountain EMC had been sending a small city power bill to Union County Government since 2009.

At Sole Commissioner Lamar Paris' suggestion, the city will reimburse the county half the total amount, which will end up being \$5,392.10.

In other business, the council approved the FY 2019 contract with the Georgia Department of Corrections for detainee labor at a cost of \$39,500.

Also in the June 5 meeting, the DDA Board announced that it is currently in negotiations for the sale of the two parcels of land facing Georgia 515 there at the development.

Later that day, during the June 5 meeting of the Blairsville City Council, DDA Program Manager Darren Harper updated councilmembers on the latest happenings of the development authority.

"Earlier today, the DDA Board met, and we have approved and signed a contract for the sale of one of the parcels," said Harper. "We're very excited, as is the building owner, Steve Cockerham, and he's going to be building the building that we talked about

quite a few months ago."

Continued Harper: "Two floors of retail. We're looking at 4,000 square feet per floor. So, we're going to have 8,000 additional square feet of retail space, and another 4,000 square feet of residential space."

Harper also discussed a recent meeting between himself, Blairsville Mayor Jim Conley and Cockerham concerning a coordination of efforts, as the city and DDA are working out formalized parking on the Haralson Property, the construction of which will coincide with Cockerham's building plans.

"The contract we signed has got a few little things that we're hashing out, but he is ready to get the ball rolling," said Harper. "I've already reached out to several of the businesses outside of the community looking to Blairsville.

"And Steve is willing to do pre-leases so that we can get it stacked and ready to roll as soon as they're ready to open up."

Cockerham also spoke in the meeting, thanking Darren, the DDA Board and the mayor for all their help getting the new development project finalized. They have done most

of the work on this," said

Cockerham. "They drew up a

rendering and a vision for what that site will look like, what that building will look like "I'm real excited about it and just want to pledge to you that we are going to do a first-

class job with it, and it will be a

project that we all can be proud

of. I'm very excited to do it." As a final DDA update for the council that evening, Harper told them about the two other Haralson Property parcels that are currently under

with one lot left.' Councilwoman Mary Ruth Cook asked about the addition of bathrooms downtown, and Harper said they'll be adding those "at the time we do the parking lot."

'The funds from the sale of these properties will help us achieve that goal, but we're looking to do everything in one fell swoop," said Harper. "It's going to be a messy summer in terms of construction, but we're going to go ahead and get through this, and we will be better prepared for future growth."
