It was while at the hospital and rehab center that I decided my fate was to continue working at the newspapers. These two facilities taught me a lot.

They taught me not to give up hope, that eventually, the long, hard spiral staircase I was facing - well, it wasn't all uphill.

Here I am today, I'm back in Blairsville, and on the mend - again. My current situation includes a lot of hard work at Benchmark Physical Therapy here in Blairsville. It's a top notch outfit filled with certified professionals. It's also stocked with outstanding equipment.

My sister, and one of my former home healthcare professionals recommended it to me. I knew I was in the right place as soon as I rolled in the door.

Commissioner's Questions

Jail Part IV Continued from last week.

Q. The Sheriff has given us a tour of the jail and has shown us the overcrowding in the jail with mattresses on the floors and prisoners crowded in together. There are also apparently additional issues with door locks, tower controls and security cameras. Instead of the county continuing to spend

money on "nice" or "fancy" projects and property, why can't the county fix the jail or build a new one? The last three weeks I began

answering this question and have continued those answers this week. The jail is a complicated issue.



Q. If it cost more to keep a pris-

oner incarcerated locally, why not send them all out of county?

A. Doing this would create a burden for the Sheriff's Department by having to transport prisoners to other locations and the court system for having to plan around their transportation. However, when we are overcrowded and can get by with housing only a few inmates out of the county, it is a reasonable and cost effective alternative.

Q. So, if we build a new jail, why will it cost more to house the prisoners here locally than it does out of town.

A. The following rates per day of incarceration were published by the state for 2014: State Prisons \$56.19/day, Integrated Treatment Facilities \$67.76/day, Private Prisons \$50.67/day, Probation Detention Centers \$55.08/day. Typically, because these are larger facilities, the per day cost can be less. Some counties in the U.S. report cost of over \$100/day per prisoners. Juveniles can cost nearly \$200/day to incarcerate. It is almost impossible to narrow down the exact cost except to know that it is significant. So, having to house an inmate out of the county at \$35 to \$40 per day occasionally, is very reasonable and much more cost effective than building and staffing a new jail with 125-150 beds at a \$8 million to \$15 million price tag.

Q. Does it bother you that the jail is overcrowded and prisoners are sleeping on the floor?

A. Those in jail made a choice to violate the law. No one forced it on them. Sure, it may have been from drug abuse or some



Radon Testing

Radon is a colorless, odorless and tasteless gas that is directly linked to increased rates of lung cancer. In fact, it is the second leading cause of lung cancer, after tobacco smoke. It is a common problem in mountainous areas as uranium breaks down

into radium, which eventually degrades From the into radon. Radon **Ground Up** can enter the home through well water Melissa and the foundation Mattee itself. Unlike for carbon monoxide and other harmful gases, there are no detectors for radon levels. The only way to determine if you have high levels of this gas is to test it yourself. Pickens, Fannin, Union and Towns have some of the highest radon contamination rates in the state. In Union County alone, 47% of the homes tested showed unacceptably high levels of radon gas. If the air in your home tests positive for higher than 4 picocuries per liter, it is recommended that you take steps to reduce the levels of radon. Though you can take many steps yourself, such as increasing circulation and ventilation in basements and crawl spaces, it is highly recommended that you hire a professional radon mitigator. There are two different tests to determine radon levels in your home: an air test and a water test. Air tests can be purchased from local retailers or from www.ugaradon.org. Once you purchase your kit, make sure all exterior doors and windows have been closed for at least twelve hours, aside from normal exit and entry. You can run your air conditioning or heat as you would normally. Hang the test kit 2 to 6 feet off the floor on the lowest habitable level of your house that I used regularly. Leave the test kit for a minimum of 3 and maximum of 7 days. Once the required time has elapsed, seal the envelope, record the starting day and time and the ending day and time. Mail the test kit to the designated address in your kit immediately to ensure accurate results. Radon water tests can be purchased through the extension office for \$40. These tests are different from basic water tests because they require specific containers and collection methods. First, remove any filters and aerators from the faucet. The kitchen faucet is usually the best water source as it is usually the most commonly used in the house. Run cold water for 15 minutes to flush the system, and then reduce the water to a gentle flow and fill a large bowl with it. Submerge the first sample bottle and its lid under the water and allow the bottle to fill. Cap the bottle while it is still in the water and turn it upside down. If there are any air bubbles, empty the See Mattee, page 5A
