Authority for the purpose of Union General Hospital will being sold. This is the property that was to become the 4-H Shotgun Range.

Paris explained that by transferring the property to the Development Authority, there would be more flexibility in how the property might be

The commissioner adopted a resolution approving a right-of-way sale to the Georgia Department of Transportation of county property located near the Farmers Market for the upcoming Georgia 515 widening/relocation project to take place between Blairsville and Young Harris.

GDOT purchased the 1.264 acres of right of way for \$450,000.

Paris also adopted another resolution approving what amounted to the donation of 0.076 acres of county land in the same vicinity to GDOT for use in the Georgia 515 project, citing the \$450,000 sale and the fact that GDOT made the Farmers Market Way intersection possible for the

Also on the agenda, Commissioner Paris approved an agreement between Air Methods Corporation and Union County for emergency air medical transportation services for county residents and their households to run June 1, 2019, through May

The amount of this agreement is not to exceed \$76,765, and the county and of appraised property values,

The commissioner approved an agreement with the Georgia Department of Corrections for six work details between now and June 30, 2020. The cost of these details is \$39,500 per detail for a total of \$237,000.

He approved an agreement with Patrick Malone for coordinating the awareness of the 2020 U.S. Census in Towns and Union counties for the period of June 1, 2019, to

The cost of this agreement will be \$1,000 per month for a total of \$12,000.

Paris approved an agreement with Legacy Link for \$95,000, which is the required local share of operating the Union County Senior Center during Fiscal Year 2020.

He also signed a letter committing \$11,450 in local share monies to be used by the Legacy Link Area Agency on

approved a \$620,000 contract with Georgia Mass Appraisal and Service, Inc. for the purpose of reevaluating property values in Union County. The company will provide the county with updated pricing

real property by performing

field inspections of all parcels in the county, of which there are 22,000. Assessed property values should be about 40%

Paris said. Since 2015, that ratio has dropped because of climbing appraised values. The new pricing schedules will get assessed values back in line with appraised values at the

The commissioner said spending \$620,000 every 10 years is much less expensive than hiring permanent employees and buying them vehicles to accomplish the same thing.

Also in the meeting, Paris accepted six grants for various Enotah Judicial Circuit Accountability Courts. He said these are passthrough grants from the state to the courts and not money from residents.

The commissioner approved a quitclaim deed between the Blairsville Downtown Development Authority and the county for two tracts of land totaling roughly 1.4 acres located immediately southeast of the Union County Courthouse.

Previously, the land had historically been used by the county but belonged to the Haralson Family, which sold the land as part of the Haralson Property Development to the Blairsville DDA several years

Paris said the county helped the DDA and city with their efforts to install Bob Head Street through the Haralson Property Development in 2016, and that the quitclaim deed is essentially the DDA honoring that past commitment and the county's historical use of that property.
