Q. How will CodeRED benefit me?

A. The CodeRED system allows Union County EMA to provide notifications that may require immediate action (such as a boil-water notice, a missing child, a weather emergency or an evacuation notice). The system delivers text, emails, and phone calls to cell or home phones. Union County EMA also uses CodeRED to send EMERGENCY notifications to keep citizens informed of emergencies such as evacuation notices, fires, floods, chemical spills, or other emergency situations. CodeRED Weather Warning is a unique service that automatically notifies citizens in the path of severe weather just moments after a warning has been issued by the National Weather Service.

#### Q. Is CodeRED an improvement over the previous system that was being used?

A. Yes, the CodeRED system is a great improvement in our communications. It will keep people informed of community events and emergencies. This information can help everyone make better decisions. #### Q. Is there a cost to register for CodeRED?

He never used profanity toward his crew, and they were always paid on time.

During my father's time, he also experienced and made memories at the gin. Dad said it was so cold one fall that his mother had buried him up to his neck in the cotton to keep him warm. Papa stopped the wagon just beyond Uncle Dan's house to take a bathroom break in the woods. While Papa was in the edge of the woods, the mules began walking. Papa said, "Whoa mules," to no avail. Again Papa spoke, but, the mules did not stop. Mind you, Dad was still in the wagon buried up to his neck and couldn't move. Papa was crouched over in the woods taking care of business. Dad said, "One of the funniest memories I have is of Papa running from the woods with his overall galluses dragging the dirt while he was trying to catch those stubborn mules. By the time I came along, the gin was on its last legs. It closed when I was very young, but, I remember it well and its impact on four generations of my family.

never used substances, while others suspected that their kids might be drinking or using oth-

Over the next several weeks, I will share highlights from the focus groups in hopes of starting a discussion in this community among parents about early prevention. This week highlights cover substance use and teen health issues and how teens should receive education about alcohol and drugs.

Many parents were surprised to learn that 90 percent of people with addictions started in their teen years sometimes even earlier. From the time kids are about 10 years old and through their mid-20's, the brain is undergoing massive changes, developing important capabilities for adulthood. These include the ability to regulate emotions, weigh the pros and cons of risk-taking, understand what onsequences might be before they happen, and problemsolve. Using substances like drugs or alcohol during this critical time can hurt teens' brains. In fact, some teens who

are even more vulnerable to adverse impacts than others. These risk factors include a family history of problematic substance use or other addictions, underlying mental health problems (such as depression, anxiety, or ADHD), childhood trauma (such as witnessing or undergoing school shootings, abuse or neglect, or violence) and being bullied. Parents were split on

how their kids should be educated about the risks around substance use. Some parents felt schools should take the lead. Once their kids have been educated about the topic, parents would reinforce the information. Not wanting to count on the school, other parents felt that they needed to have an ongoing conversation with their kids about substance use, as well as lay down the rules. These parents were worried that if they didn't take the lead, their kids would learn about substance use from the internet, social media, pop culture and their more adventurous

of older leaves between the veins. Copper shortage will show up as young leaves wilt but remain green.

Nutrient deficiency

leads to plants that are more susceptible to disease because they are stressed. Diseases can cause a nutrient deficiency because the plant isn't able to operate properly. Therefore, we can have a chicken or the egg type situation. Both issues will need to be addressed to make the plants healthy The best way to avoid

a nutrient deficiency is to do a basic soil test. It costs \$10 and you can bring your soil sample to the Extension Office. The report that you get back will have instructions on when to fertilize and how much to use. If the plants you are growing have a unique nutrient requirement that information will be included as
