#### Local woman finishes World War II era quilt mother began in 1944

Kathleen Wiley was just a child when her mother, Edna Cross, started a patriotic quilt for her husband William in

At the time, William was serving his country in the U.S. Army and had been deployed to Germany, where he fought in the Battle of the Bulge. When he returned home

to Fallsburg, New York, in folded the unfinished red, white and blue quilt and put it in a box, where it lay forgotten for

"This year, I found the box and opened it," said Wiley. "I unfolded the material to discover the cloth stars sewn on the quilt top. Everything was there, even the cloth batting rolled up in tissue paper to keep the batting from matting together. Cotton seeds still clung in places to the cotton.

"I remember, as a child, no television then, so we

### Sheriff's Office asking for public's assistance in finding wanted man

The Union County Sheriff's Office is seeking the public's help in locating Joshua Lee Bryant, a fugitive from

Authorities were still searching for Bryant as of press time Monday, and folks can check in with the "Union County -Georgia Sheriff's Office Facebook page for the latest information on the search. He is not thought to

be armed but is considered dangerous, according to the Sheriff's Office, and anyone with information regarding his whereabouts has been asked to call 911 immediately.

Bryant is a 32-year-old white male standing 5 feet, 7 inches tall. He weighs about 155 pounds, and he has brown hair, brown eyes, and a barbwire tattoo on one of his arms.

His last known address was in the Copperhead Road area of Union County.

On Friday, June 28, Bryant bush bonded during a police chase after wrecking an allegedly stolen truck in a collard field in the north end of the county off Tate Road around 9:45 that morning.

He fled the scene on foot and was able to evade a roughly five-hour manhunt by multiple responding law enforcement agencies, including the Union County Sheriff's Office, Fannin County Sheriff's Office, Cherokee County Sheriff's Office of North Carolina, and officers with the Georgia State Patrol and Department of Natural Resources. The next day, a Union

County deputy spotted Bryant several miles from the scene of his Tate Road crash, and as of Saturday, he was believed to be in the vicinity of West Culberson and Voyles Town roads. It all started early Friday

morning, when the Gilmer County Sheriff's Office took Bryant into custody for allegedly attempting to shoplift at the Ellijay Walmart,

custody in Gilmer County, after which he allegedly stole a truck and fled the area, Davenport Patrol deputies with the

#### Former DFCS employee arrested for alleged illegal baby trade attempt

BLUE RIDGE - A former employee of the Union County Division of Family and Children Services and her husband were arrested last week for allegedly trying to

trade a car for a baby. "On Wednesday, June 26, the Georgia Bureau of Investigation was requested by the Fannin County Sheriff's Office to assist in an investigation regarding a couple persuading a mother to sign over her rights to her child for the consideration of a vehicle," the GBI said Friday.

The couple was identified as Rebecca McClain, 36, and William Ryan McClain, 44, both of Blue Ridge.

'As the investigation unfolded, it became clear that the 10-month-old child had been in the care of the McClains for several weeks and they were interested in the McClains were arrested



adopting the child," the GBI said. "Rebecca McClain is a former employee of the Union County Division of Family and his or her child." Children Services.

Authorities executed a search warrant at the McClain residence off Laurel Crossing Road in Blue Ridge on Thursday, June 27, after which

"The child was found "It appears McClain in good condition and was taken into custody by DFCS and has been placed in foster care at this time," the GBI said. "This investigation is ongoing and upon completion will be provided to the Appalachian Judicial Circuit District Attorney's Office for prosecution.'
