We also traveled over to the Civil War Battlefield called Shiloh just outside of Corinth, Mississippi. I can remember him being very sad as we walked through the solemn place. He would tell me about the sacrifices the men that died there made for their country.

Papa also always made time each Sunday for worship. We never missed Church, and he could always be found on the Deacon's Bench at Union Hill Congregational Methodist Church each Sunday. I think one of the most important things he gave to me were his stories. Many of the things of which I write first came to me as a result of his experiences and memories. I would like to have him back with me. I wish that you could meet him. But, he is in a better place, and as my great-grandfather Lon said all those years ago, "Let the boy sleep. He is feeling a good kind of tired." Papa lived a good life and deserves his reward.

never used substances, while others suspected that their kids might be drinking or using other drugs.

Over the next several weeks, I will share highlights from the focus groups in hopes of starting a discussion in this community among parents about early prevention. This week highlights cover concerns about how to parent for prevention.

Parents who were certain that their kids had not engaged in any substance use shared these strategies related to prevention that they found useful:

Creating an open and ongoing dialogue where their kids can "tell them anything."

Actively having prevention discussions when it comes to substances, not waiting for the school, friends or social media to fill in the blanks.

Setting their own example as parents, like modeling ways to reduce stress or relax without turning to alcohol or other substances.

Using techniques to monitor kids' behavior (such as making sure they had access to all passwords and social media, driving them places and listening to backseat conversations, meeting kids' friends, etc.).

Being willing to talk to other parents about which kids are reported to be using substances — including their own.

This last point about talking to other parents about their own child or their child's friend using alcohol or other drugs created quite a lively discussion. On the whole, parents said they would want to know if another parent found out that their child was using substances and would welcome a call. Several parents were conflicted about what to do if their child reported substance use on the part of a friend. They were concerned that other parents would resent a phone call or be angry, even if they themselves would welcome the information.

fines that total \$30,100? Does that even cover coffee?

2. The number of pills consumed, if not distributed as they testified, brings us to another question. How did these men function as competent doctors on any level taking this many pills? I am not a math major, an addict, nor in law enforcement, but number of pills, prescriptions, plus drug task force equals distribution in my feeble mind.

3. Did they distribute? If so, have them sit with a parent whose child committed suicide or listen to grandparents stumbling through an explanation to their grandchildren of why they cannot go home or be with their mother. Have these men stand in line at a food pantry, do without butane for their mobile home, or have their wrecked car sit in the driveway because they can no longer get insurance.

4. Did they lose "everything" as their supporters testified?

I believe it is self-evident, you don't sit on the board with Andy Williams, former president of United Community Bank, without money flowing into it by various means. Wise money management, even if your business is not illegal, would prompt you to distribute the wealth into various holdings under the names of family members, trusts and other tax shelters advised by your advisors. In this way, money is protected in the event of personal legal claims, and seldom is "everything" lost.

5. What is the rate of return to this type crime? Reportedly Heaton was investigated twice before and warned but continued on. Would any of them continue on if their licenses were reinstated?

6. If these three men had been residents from Florida, New York, or even Atlanta, would Judge Story's sentencing been any different? If these had been men of color, would they have had five years of delayed hearings, etc., etc.?

Judge, my appeal for your resignation would probably fall on deaf ears. I am nobody ex-

cept a faithful grandmother, a retired counselor and an active listener. I would applaud, however, if somehow you and your conscience recognize it is your time to retire.

gutters, decks, and fences, and cleaning up anything combustible around the house—the kind of steps science shows are most effective in reducing home wildfire losses.

Concerns over "canceling" wildfire preparedness this year are not just a public relations concern. This spring, fire departments and state governments observed not only the expected seasonal increase in wildfire conditions, but also worrisome human behaviors.

In Washington, stay-athome orders also translated into "burn your debris piles," and in April the state's forestry agency reported an increase in wildfire starts. Colorado fire marshals reported that people unable to recreate in closed suburban parks were heading to more remote state and federal lands, where they risked

sects, grubs, or worms that are in its path. It could also strip away the outer layer of any roots that it meets.

There are not many biological controls for fire ants in the United States because they are an invasive species. Fire ants are native to South America and have many natural enemies there. Researchers have to be very careful about introducing a natural predator, because the effects of that introduced species are unknown on our ecosystem.
