paper ballot savings, the EMC will be saving an additional \$20,000 on this year's annual meeting by cutting advertising costs, forgoing door prizes and holding the event during the week at co-op headquarters in Young Harris, on Thursday, Sept. 26.

The annual meeting cost about \$100,000 in 2018, so the \$55,000 savings in 2019 will result in a cost reduction of more than 50% for the annual gathering of the membership.

Also in the July 15 regular meeting, directors signaled their continued support of the EMC being a conduit for local development by helping Chatuge Regional Hospital secure a \$2 million loan through the USDA Rural Economic Development Loan & Grant Program.

All funds will be borrowed at zero interest, and the EMC will act as a passthrough for the funding, which will help the hospital to build new medical facilities in Hiawassee and in Hayesville, North Carolina.

The process is still in the paperwork stage and should be finalized in the coming months.

In other co-op news, EMC General Manager Jeremy Nelms discussed the board's recent approval for access to about \$39 million in federal loan funds, which the EMC will draw down on as needed for capital projects in the next four years.

July board meeting, pointing out that it's better to have low-interest loan money available if needed rather than raising rates to accommodate future growth and projects.

Nelms said that, moving forward, he would seek the hoard's permission before

money," Nelms said in the

board's permission before using any loan money to fund projects.

The board voted that evening to accept the funds by approving a USDA Rural

Utilities Service loan resolution and corresponding documents.

On the rate front, Nelms announced that new Tennessee Valley Authority CEO Jeff Lyash said he would be advising the TVA Board not to implement any more of the planned TVA

rate increases, which have been

carried out for years to help

the TVA modernize and pay down debt.

This means that the 1.5% wholesale rate increase on the energy portion of member electric bills that was expected to occur this October as a result of TVA's impending rate action will, in all likelihood, not take
