A. A dispossessory can be filed in Magistrate Court by a landlord who wants to have a tenant evicted. A landlord must comply with Georgia Landlord/Tenant law. The filing fee for this action is \$81, which includes service for one defendant, with each additional person to be served costing \$25.

Q. I am a tenant in a rental property. Can I not pay my rent until the landlord makes repairs to the dwelling that I have requested? Or will they still have the right to evict me?

A. Each situation is different. There are some helpful resources for both landlords and tenants, such as the Georgia Landlord-Tenant Hotline at 800-369-4706 and Georgia Landlord and Tenant handbook available for viewing online at www.dca.ga.gov.

Q. How are garnishments handled? A. If the amount to be

garnished is less than \$15,000 a garnishment can be filed in Magistrate Court. A plaintiff filing a garnishment must provide the court proof of a judgment issued against the defendant to be garnished. There are two types of garnishments: wage garnishments and bank garnishments. It is up to the plaintiff to know which type of garnishment they want to file, along with providing the court with an address for the defendant's bank or place of employment. The filing fee for a garnishment action is \$106.

# Q. Will the Court find the defendant for me?

A. No. It is up to the person filing a claim to provide the court with a physical address for the defendant at the time of filing case.

So, my wife nor I could go home until they came to get the box. Now, I always inspect everything before bringing it home.

out their parents' knowledge. Many who buy drugs online do it through the so-called "dark web" – a part of the internet you can only access using a special anonymous browser. They purchase drugs using the virtual currency, Bitcoin. Because of the anonymity, sites on the dark web are harder for law enforcement to shut down.

In addition, the internet has become one of the main ways to sell synthetic opioids like fentanyl, which has become a leading cause of deadly drug for giving a pill to someone who later overdosed.

Check out their "searches" to see their browsing history on their computer or cellphones. Keep an eye out for any "How to buy \_\_\_\_\_ online" -type searches. Bring up anything that causes strong suspicion. This may be an uncomfortable conversation and you may also be accused of spying (which you are technically doing). But be sure to let him or her know that you are worried and only want to keep them safe. Make sure you point out recent cases in the news about young people overdosing on drugs. You may also want to invest in one of these "Parental Control and Monitoring Apps.' Monitor their delivered packages. For obvious reasons, drugs are often delivered in unmarked and discreet packages. If you find your loved one getting such mail or packages that you don't expect, ask them about it. You may want to stick around when they are opening the package. With drugs being more accessible than ever, the most important things you can do are to educate yourself on the potential danger while maintaining a good relationship with your child.

County Firewise program started in 2008 during an 800-acre fire on Cedar Knob Mountain. After that fire, local, state and federal agencies began working with community members to get them involved at a grassroots level. They did this by telling the Wildland-Urban Interface (WUI) story.

Those who started RSG & FAC in Towns County soon realized that they were the only ones pushing the issue, and that if they quit pushing, the momentum would roll to a stop and no one would notice. So, they gave ownership of the programs to the citizens they were trying to protect, thus keeping the programs moving forward.

In 2013, the Towns County FAC Citizens Coalition took ownership of RSG and FAC programs and developed the grassroots network and leadership to keep these programs growing. The coalition consists of six citizens and three agency representatives, all dedicated to wildland-fire safety and education.

Supporting the coalition is an ex-officio group providing technical expertise, resources and funds when needed. As control of Towns' RSG and FAC programs passed to the coalition, the development team took the lessons learned in Towns to jump-start new Fire Adapted Communities in surrounding areas using FAC, RSG, and FW through peer-to-peer contacts. Union, Rabun, White and Gilmer counties are now in the process of building citizen groups and developing coalitions to start the education process to make communities become better prepared for wildfires.

Most everyone in North Georgia lives in the Wildland-Urban Interface (WUI – living in or near forests), creating a major risk for residents from wildfire. The most important component of wildfire preparedness here is Ready, Set, Go!, which is the evacuation plan that is key to surviving a wildfire. It shows us how to be aware of conditions and be Ready; have our important items at hand or Set; and to Go when the call comes to leave so we can get out of the way of first responders coming in to protect our homes. If a wildland fire approaches and the residents and emergency responders don't have a plan in place to get out of harm's way, then all other FAC components become useless.

The RSG Program ties in well to the existing Towns

It is no virtue to speak whatever is on your mind. ("A fool uttereth all his mind" Prov. County Firewise program, because many of our mountain communities have narrow roads and usually just one entrance. Ingress and egress are critical issues here, and a large-scale evacuation is almost impossible, making Ready, Set, Go! extremely important to our residents and

emergency responders. Between the 2008 fire and spring 2013, Towns had only three Firewise Communities. But since the Chestatee-Chattahoochee RC&D Council received the FAC grant in mid-2013, 18 more communities have been added to the list of communities that are better prepared for emergencies. Grant funds were combined with matching funds to pay for salaries, travel and needed supplies; to have personnel attend training on new RSG/FAC methods; and to share what was learned during the development process. A successful wildlandfire safety and education program isn't easy to start, because we all tend to ignore risks near our homes until smoke and embers are blowing over the ridge-and then it's too late. A program such as this must have its own spark and must be properly fueled; and once ignited, it will spread on its own through the grassroots channels. caterpillars. Therefore, scouting early is essential. Sevin is an effective product that has been around for a while. Products containing spinosad or Bacillus thuringiensis have organic options and good control of armyworms. Applying as late in the evening as possible is best because that's when armyworms will be the most active and pollinators the least active. Whenever using pesticides, always read and follow the label before the application.
