Residents, staff tested after COVID outbreak in nursing home

Union General Health System is dealing with a COVID-19 outbreak at the Union County Nursing Home after 20 residents, or about 15 percent of the population, tested positive on a single hall.

The outbreak has resulted in the nursing home's first resident death from COVID. A second resident is being hospitalized currently, with the 18 other known positive residents remaining well enough to stay in the nursing home under observation.

All residents and employees have since been tested, and results are

residents are not experiencing any symptoms, and all are being isolated together on a specially prepared hall inside the nursing home per Centers for Disease Control and Prevention guidelines, Union General Chief Nursing Office admitted as a resident. Julia Barnett said.

Paris to hold public hearings on county property tax increase



Union County Sole Commissioner Lamar Paris is planning to raise the county's portion of property tax bills by 19.98 percent this year.

The millage rate will tentatively be going from a 2019 rate of 6.144 to a 2020 rate of 7.361 for a year over year increase of 1.217 mills. Compared to the rollback rate, the increase will be 1.226 Paris will be hosting three

public hearings for community input on the tax increase: two on Aug. 20 at 10 a.m. and 5 p.m., and a third on Aug. 27 Fortunately, county-

Union County Schools welcomed students back Monday, though the halls were about 25 percent emptier than usual, since many families chose to keep children home using the district's completely online learning option due to

It's been more than five months since students graced the halls of any building on campus, as school systems shut down statewide in the spring at the onset of the pandemic, so staff and students were particularly excited to get back to it Aug. 17.

"Everybody has been waiting for this moment since we got out in March," Elementary School Principal Jerry Bavero

Department of Public Health shines light on COVID-19 trends General Election showdown Nov. 3

As COVID-19 numbers continue to rise in Union County, with a nearly 40 percent increase in cases in the last two weeks alone, the Georgia Department of Public Health seems to be seeing light at the end of the tunnel.

According to a press statement released Friday, the department said that, statewide, COVID-19 appears to be in decline, both in terms of overall case numbers and hospitalizations.

"During 8/3-8/9, last nine days at time reporting

Georgia's weekly statewide case numbers decreased by 7 percent," Georgia DPH said. The Centers for Disease Control and Prevention indicates that Georgia has experienced a 22 percent decrease in case numbers over the past two weeks relative to the two weeks prior to that, and that we have seen a downward trajectory of

"The highest percentage of case numbers still come from the high population counties in metro Atlanta - Fulton, Gwinnett, DeKalb, Cobb have the highest case numbers – but these counties are actually experiencing decreases now."

cases for two weeks now.

Additionally, as of Aug. 13, the state was reporting over 1.9 million COVID-19 tests in all, with eight of the

witnessing more than 25,000 tests per day, including private tests and more than 750,000 tests from 180 DPH specimen collection sites in Georgia.

"Positivity rates are decreasing from 11.86 percent on July 27 to 10.98 percent on Aug. 3 to 9.5 percent on Aug. 9," DPH said. "Daily hospitalizations have decreased 6.62 percent in the past seven days (as of Aug. 14).

Still, as cases increase locally above the 1-percent of population threshold, people continue to have questions about the state of the virus and how best to perceive it.

Enter Public Information Officer Dave Palmer with District 2 Public Health, who says residents should

Clyde, Pandy headed for



Following the Aug. 11 General Primary Runoffs, Republican Andrew Clyde and Democrat Devin Pandy are headed for a General Election showdown to represent Georgia's 9th Congressional

District in the nation's capital. On the Republican side of the 9th Congressional race, districtwide, Clyde beat his opponent Matt Gurtler by more than 11,000 votes. Here in Union County, Gurtler - who has served as District 8 State Representative for the last four years – won with 2,766 votes to

The Democratic ticket for the 9th Congressional seat featured Devin Pandy and Brooke Siskin, and Pandy won

Clyde's 1,852.

the district handily with 68.46 percent of the vote. Pandy took the contest in Union County also, securing 476 votes to Siskin's 216.

Interestingly, voters in the 9th Congressional race were overwhelmingly represented

by Republicans, who cast 88,905 ballots compared to the Democrats' 11,704.

Stemming from their victories last week, Clyde and Pandy will face off Nov. 3 for the office of U.S.
