

Softball: Union Co. thumps White, three ranked opponents on deck

Lady Panthers to visit No. 4 Commerce and No. 10 East Hall, host No. 6 Heard County

Cleveland - Senior Trinity Queen picked up her second win of the year as 5th ranked Union County (2-1) used a fiverun sixth to pull away with a 10-3 victory at White County.

The Lady Panthers scored three runs in the first inning and two in the third to jump ahead 5-0. White County benefited from a two-run error to get on the board during the bottom half of the third, then inched closer with a run in the fourth to make it a 5-3 game.

Queen, already a stellar defender in the pitcher's circle, provided Union County with the play of the game in the bottom of the fifth. With two down and Lady Warrior runners on second and third, Queen snagged a line drive en route to centerfield, which would have likely knotted the score at 5-5.

In their ensuing plate appearance, Queen's bat and some heads up baserunning sparked the Lady Panthers' five-run sixth. Following a base hit to center to lead off the inning, Queen alertly took an extra bag with no one covering second base. Moments later, Queen's courtesy runner, Caroline Karnes, was moved to third by an Aubrie Banton sacrifice bunt.

Ansley Collins put runners at the corners when she reached on a sacrifice bunt, but White County tried to catch Karnes in a run-down at third instead of taking the out at first. Karnes was able to get in under the tag on a bang-bang play, bringing the Lady Warriors' coach onto the field to argue

After Collins swiped single and a hit-by-pitch, but second, consecutive RBI bunt singles by Caley Davis and freshman Sierra Burnette allowed Union County to open up a 7-3 advantage.

Potts went 1-for-2 with two walks, two runs and a steal; Collins was 1-for-3 with a run and a stolen base while Queen finished 1-for-4.

Senior Hannah Patton doubled and walked during a 1-for-3 day. Davis drove in a run and swiped a base; Katie Byers scored three times and Emily Byers scored once. Banton walked and stole a base; Sierra Burnette finished 1-for-1 with a pinch-hit bunt single.

The Lady Panthers' 10run outburst was ignited by three in the first as Potts and

Patton drew consecutive walks to open the game. Roxbury cleared the bases with a tworun, one-out double before coming around to score later in the frame.

Patton and Sisum began the third with a double and triple, respectively, before a Roxbury sacrifice scored Sisum for a 5-0 score.

A two-run error at first allowed White County to pull within 5-2 in its half of the third; then a two-out single made it 5-3 in the fourth.

Up next: Despite its inclusion on an earlier version of the 2020 softball schedule, Union County dropped out of last weekend's Dalton tournament.

On Monday evening, the Lady Panthers paid a visit to Commerce - the fourth-ranked team in Class A Public. No results were available as of Monday's deadline.

Things only get tougher this weekend when Union County hosts a doubleheader with Class AA's sixth-ranked Heard County in a rematch from the 2018 Class AA State Tournament. Next Monday, Aug. 24, the Lady Panthers continue their early-season gauntlet with Class AAAA's No. 10 East Hall.

"The next four games will be very exciting for our program," Mitchell said. "It is not often that you get the opportunity to cross paths with some of the best programs in the state. Commerce, Heard County, and East Hall are all three going to challenge us in different ways.

"I look forward to facing each of them as a means to measure where we are early in the season. I have confidence that our girls will respond to the big-game atmosphere."

Including the opener vs. Lumpkin County (No. 8 in AAA), nine of Union's first 12 games are vs. ranked opponents from the Atlanta Journal-Constitution Preseason Softball poll. Speaking of Lumpkin, the Lady Panthers will visit Dahlonega on Aug. 31 following an Aug. 27 meeting with Fannin County.

Union will host Commerce in a Sept. 3 rematch before visiting Fannin County five days later. Region 8-AA play will offer no reprieve for the Lady Panthers as they open with the top-ranked defending State Champion Banks County on Sept. 10 in Blairsville.

ersham Central Lady Raiders in the season opener, falling 2-0 (9-25, 15-25) to the Class AAAAAA opponent.

"Habersham is a solid team and definitely outplayed us," Union County first-year coach Anna Chapman said. "It's obvious that they have a solid program that starts building its players at younger ages. We were able to play some impressive rallies and show them what we have to work with.'

Tied at 1-1 in the first set, Habersham rattled off ninestraight points to grab an early 10-1 advantage. Union County was unable to recover, never getting closer than an 11-4 margin before the Lady Raiders put things away by taking seven of the next eight points for an 18-5 score, eventually prevailing 25-9.

With first-set jitters out of the way, the Lady Panthers appeared a bit more poised in the second stanza, using a 4-0 spurt to pull within a point after falling into a 9-4 hole. Union continued to hang around, trailing 12-11 at the halfway point before Habersham began to open up some breathing room with



four-unanswered of its own.

Down 16-11, the Lady Panthers kept within striking distance at 17-12 and 19-14, but Habersham ultimately proved too much, taking the set and the match 25-15.

In Thursday's finale, Union County met Class AAA Lumpkin, who already edged Habersham Central 2-1, and put up a better fight during another 2-0 defeat.
