# **Commissioner Paris: 'Property taxes are going up'**

Union County Sole Commissioner Lamar Paris announced in his Thursday, Aug. 16, regular meeting that property taxes will be going up this year.

The 2018 millage rate is tentatively increasing to 6.626 mills, up 0.84 mills from the 2017 rate of 5.786 mills.

This will be the first time since 2014 that the county tax rate has gone up, when it increased by 0.482 mills from the year before.

The new millage rate is projected to bring in \$8,352,167 in countywide property taxes, which is \$1,193,810 more than last year, reflecting a 16.68 percent increase in 2018 projected tax collections over 2017.

prior to its final adoption. The hearings will occur at the Union County Courthouse on Tuesday, Aug. 28, one at 10 a.m. and another at 6 p.m., and a third on Tuesday, Sept. 4, at 4:30 p.m.

Without the tentative tax increase, the 2018 millage rate would be no more than 5.767 mills, according to the commissioner's office, which is actually 0.019 mills less than the 2017 rate.

"The proposed tax increase for a year for a home with a fair market value of \$100,000 is approximately \$13.95," per the commissioner's office. "And the proposed tax increase for a year for nonhomestead property with a fair market value of \$200,000 is approximately \$37.92."

the economy is the best it's been in years?" said Paris on Aug. 16. "Well, our medical costs have escalated about \$750,000. Our housing of outof-town jail prisoners will exceed \$100,000."

"While it is said that everyone that wants a job has a job, it is not quite that simple," said Paris. "For counties to maintain employees, we are now having to compete with higher wages in the public marketplace.

"We are facing the first inflation in years, and we are seeing the cost of gasoline, tar, asphalt, vehicles and other supporting supplies continue to go up ahead of our revenues.

"Our E-911 and public safety radios and equipment upgrades that we will have to do this year, that we've been putting off, will exceed \$650,000 in costs.

"We will have to purchase a ladder truck for the fire department, one that we've been avoiding for years. And we are starting the process of adding a fire training center to provide more intense training for the firemen that we have competitive with neighboring to maintain better abilities

to protect you and protect themselves."

And the list went on, with the commissioner describing a revolving door of need for equipment upgrades at the fire department, road department, county maintenance department, "and, really, every other department.

"We are all very sorry that this will be required, but our accounting director has been working diligently on our next year's budget, and we just have no choice," said Paris. "We hope everyone understands that Union County is a growing county.

"Our expenses have increased 6 percent this year, and our revenues have only gone up 2 percent. Property digest values, which is the value of the increases in new homes and new property, only went up 2 percent this year. 'Part of that issue is that,

### **Cass Larson of TVA talks** rate increases with Blue Ridge EMC

YOUNG HARRIS - The Tennessee Valley Authority is moving forward with another annual base-rate power increase, despite pushback from the Blue Ridge Mountain EMC and other local power companies.

Members of the TVA Board of Directors were expected to approve another wholesale rate adjustment in their Aug. 22 board meeting, which occurred after press

The adjustment will take effect on Oct. 1, and EMC members can expect to see marginally higher annual power costs pass through to their customer bills.

TVA has implemented similar annual increases since 2013 as part of its 10-year plan to cut fuel costs and tackle debt, and the latest rate increase will amount to a 2.4-percent upward

adjustment on TVA's portion of wholesale power costs.

In dollars, moderate power users can expect to pay roughly \$27 more each year after the increase goes live, while larger households with greater electric needs are likely to see annual bills increase by as much as \$40.

Cass Larson of TVA

traveled to Young Harris to speak on this issue in the Aug. 14 regular meeting of the BRMEMC Board of Directors.

Larson is vice president of Pricing and Contracts with TVA, and he delivered a presentation aimed at easing the board's concerns over TVA rate practices moving forward.

Fortunately, TVA has overperformed in revenue gains thanks to its rate increases and cost-cutting measures over the last five years, and Larson told the EMC board that he was confident TVA would only need to approve one additional rate increase after this year's adjustment goes into effect.

This is a positive development for TVA power consumers, as the federal agency is signaling its abandonment of the last three years of planned cost adjustments, likely making 2019 the last year for the TVA Board to approve a rate increase

## Blairsville woman killed in Murphy, NC, murder/suicide

MURPHY, NC - A Blairsville woman was shot and killed in an apparent murder/ suicide in Murphy, North Carolina, on Monday, Aug. 13, according to the Cherokee County (NC) Sheriff's Office.

In a press release concerning the incident, the sheriff's office confirmed that the victim was Tamma Lee, 57, of Union County, and the perpetrator was Nathan Mashburn, 27, of Fannin County.

The sheriff's office declined to elaborate on the exact nature of Lee and Mashburn's relationship, citing an investigation that was still active and ongoing as of press time Monday.

Cherokee County (NC) E-911 Communications received a call at about 8:20 p.m. on Aug. 13, indicating that a female had possibly been shot at a residence on Twin Pond Road, in the Hiwassee Dam Community of Cherokee County, North Carolina
