Homecoming Queen Baumeister claims crown | Nursing homes improving; family visitations started

Union County High School crowned senior Katie Baumeister as its 2020-21 Homecoming Queen before last Friday night's football game.

For Baumeister, it took a second for the revelation to sink in after hearing her name announced over the Mike Colwell Memorial Stadium public address system.

"There was a moment of hesitation where I didn't know if it was real," said Baumeister, who was accompanied by her father Kurt. "It's something that I feel like every girl dreams of, and it was a really nice

feeling." Baumeister's crowning caps off a hectic two-week period that began with the announcement of the court on Sept. 21. Since then, it's been

The COVID-19 outbreaks at Union County Nursing Home and Chatuge Regional Nursing Home continued last week, with most residents at both facilities having already tested positive for the virus as of Friday, Oct. 2.

These outbreaks line up with the recent uptick in community spread, though positives in Union and Towns counties appear to be on the decline, remaining elevated in recent state reporting data due largely to the number of tests being conducted at the local nursing homes.

Other long-term care suffered outbreaks as well, including nursing homes in Photo by Todd Forrest Fannin, Lumpkin, Rabun and

Union County experienced only one new positive among nursing home residents last week, bringing the total number of residents testing for COVID to 102 of 118, or about 86% of the

Eleven people have died in connection with the Blairsville outbreak that began in mid-August, with the last resident death as of press time having occurred the week of Sept. 21.

As far as health care workers, an additional 16 facilities in the area have nursing home employees tested positive in Union last week, bringing the total number

Greystone fire ruled accidental; fifth commercial fire in 10 months

State investigators with the Insurance and Safety Fire Commissioner's Office have ruled the Sept. 28 blaze inside the Greystone Building on Georgia 515 an accident after reviewing lab results returned Monday.

No one was hurt in the fire, which, again, has been deemed accidental in nature by the state.

The cause of the fire has been the topic of much speculation on social media, as the Greystone Building houses offices for several local businesses as well as the Union County Republican Party, giving rise to accusations of political motivation.

Union County Fire Chief David Dyer said the rumor that the Fannin County GOP Headquarters also burned that night was just that – a rumor,

Charges pending after driver accidentally runs woman over

A Union County woman exiting Home Depot around 9 a.m. on Sept. 29 was run over by a truck in the store's parking lot, according to the Georgia State Patrol.

The male driver of the Dodge Ram 1500 pickup was searching for a parking spot when the accident occurred, GSP Cpl. B. Taylor said.

Heading north, the driver had come to the end of a row of parking stalls near the main entrance when another motorist at the intersection motioned for him to turn left in front of the store, Taylor said.

He initiated his turn without realizing that a woman was crossing from the store entrance to the beginning of

He chose the Historical Society as a good organization to help "since most of their members are elderly or people who can't put the time and effort in that the site needs."

While performing his project, Bryan said he enjoyed his time at the Historical Society and found it interesting to learn about local history.

After having completed his Eagle Scout Project, which is an achievement years in the making, Bryan said he is thankful for everything he has learned while a scout.

Advanced in-person voting for the big Nov. 3 General Election will begin Tuesday, Oct. 13, and run weekdays through Friday, Oct. 30.


People are encouraged to vote early, as turnout is expected to be higher than ever this election, potentially translating to longer than usual precinct lines come Election Day, despite the more than 4,200 local absentee ballot applications already processed.

The three weeks of early voting would normally start on a Monday; however, the Union County Courthouse where early voting is set to take place will be closed Oct. 12 in observance of Columbus Day.

All weekday early voting will occur between 8 a.m. and 4:30 p.m., and people will have the opportunity to vote on Saturday, Oct. 24, from 9 a.m. to 4 p.m. All early voting will take place in the Jury Assembly Room on the bottom floor of the courthouse, even during lunchtime.

The courthouse is still under a judicial order requiring guests to wear face masks, practice social distancing and submit to temperature checks before entering the building.

People who are uncomfortable voting in a mask may head to the polls on Election Day, as currently, facial coverings are not being required to vote at precincts, though this is subject to change. There's also the option of requesting an absentee ballot

to mail or drop off at the courthouse.

Additionally, poll workers are following COVID-19 best practices by regularly sanitizing equipment, and the Union County Government is supplying masks at the courthouse for people who don't have them, as well as hand sanitizer.

The Nov. 3 ballot features contested elections for the following federal and state offices: President of the United States; two U.S. Senate races; two Public Service Commissioner races; the 9th Congressional District seat; District 51 State Senator; and 8th District State Representative.

Also on the ballot are uncontested elections for eight local offices, including Clerk of Superior Court, Sheriff, Tax Commissioner, Surveyor, Coroner, Sole Commissioner, District 1 Board of Education and District 3 Board of Education.

The General Election features three statewide ballot initiatives for all Georgians to decide, including two proposed constitutional amendments and a referendum.

Amendment 1, if passed, would enable state legislators to use specifically imposed fees and taxes expressly for their intended purposes.
