Absentee Ballots If you ordered an absentee ballot or one just appeared you have choices. You can fill in the ballot and send it via USPS or take to the courthouse dropbox. But if you want to vote in person you must go through a process before you can vote in person. You must bring your absentee ballots with you to the polls, a poll worker can cancel it and then allow them to vote. For those who don't have their absentee ballots with them, poll workers have to call county election offices to ensure the voter hasn't already returned an absentee ballot. Then the voter has to sign an affidavit and the poll worker has to cancel the absentee ballot before they can vote in person.
