with a motion of his own on Thursday, Oct. 10, arguing that the new testimony was based on "hearsay," or the report of someone else's words by a witness, and therefore should be considered inadmissible.

Story had not ruled on the issue by press time Monday.

The October trial date, set in August, was the third trial date set in the case.

First scheduled for February 2019, the trial was moved to April due to a revision of the indictment that added new allegations against Heaton.

The April date was postponed after the defense filed a joint motion to either prevent the jury from hearing new evidence introduced by the government two weeks before the April trial date, or to allow the defense teams more time to prepare against the new allegations.

In response, Judge Story postponed the trial until Oct. 8. and now, the trial start date will likely coincide with the ending of the DeKalb County murder trial, whenever that may be.

Gowder and Heaton face 103 charges alleging conspiracy to prescribe and obtain controlled substances. Heaton is charged with 63 additional counts of prescribing controlled substances "outside the scope or professional practice and not for a legitimate medical purpose.'

The men were initially arrested on Feb. 4, 2016, following an extensive investigation by the Union County Sheriff's Office conducted jointly with various other federal, state and local law enforcement agencies.

They have pleaded innocent and posted a \$10,000 unsecured bond.

According to the U.S. Attorney's Office in Atlanta, which is prosecuting the case, both defendants are presumed innocent of the charges against them, "and it will be the government's burden to prove each defendant's guilt beyond a reasonable doubt at trial."
