on whether to begin planning or not. This was not a decision that was made lightly. There is just no way to have these events and keep people safe and protected from possibly contracting the virus.

The Kris Kringle Market at the Farmers Market will be on Dec. 5 from 10 a.m. to 3 p.m., and the Chamber of Commerce will be hosting their Holly Jolly Christmas at the Community Center on Dec. 5 starting at 9 a.m. Since this event will be held indoors, they will be following safety precautions according to the Governor's guidelines regarding COVID-19. More information will be available on these events in the coming weeks.

Q. Is the Electronic Recycling and Document Destruction Event still taking place on October 24th?

A. Yes, as long as it is not raining, the Electronic Recycling and Document Destruction event will continue as planned in the front parking lot of North Georgia Technical College from 10 a.m. to 12 p.m.

If the forecast is showing a very high probability of rain for that day or if it is raining the morning of the event, then it will be cancelled. We will announce this on the Union County Facebook Page and also the Union County website at www.unioncountyga.gov.

and take the necessary steps of wearing a mask and social distancing. Pretending the virus is not a very serious and viable concern or refusing to take it seriously is not going to make it go away any faster, no matter how hard we pray or wish it would.

Our residents have always come together as a "community" to help one another during times of need. How is it that the residents who don't wear a mask don't recognize that if ever there was a time for a community to come together, it is right now during our battle to defeat this pandemic? Is this not indeed the quintessential "time of need" for our community?

Lamar Paris, our Sole Commissioner, told me back in March, when our positive numbers were in the single digits, and again just the other day when our number of positive cases had risen to 843 (on Oct. 12), that "when and if we feel there is a serious problem, we can then consider alternative action, but we are not at that place in time now."

My question is, what exactly is the threshold for a "serious problem?" For it seems we are there or past it with the 843 positive cases and 22 deaths to date and numbers rising daily. It has been eight months now with not nearly enough people in our community adhering to the importance of wearing a mask or social distance, and as a result the virus has not gone away. That is a "serious prob-lem." What HAS gone away are businesses, restaurants, jobs and lives. That is a "serious prob-lem." So what exactly constitutes a "serious problem?"

Mr. Paris also responded to my question as to why a mask mandate could not be put in place in our community by saying, "We simply do not have the manpower to enforce such a rule without threatening the welfare of Union County residents." My question is, isn't the lack of leadership and/or lack of a plan necessary to control an active pandemic in our community and lack of information as to what constitutes a "serious problem" after eight months exactly that: the epitome of threatening the welfare of Union County residents? I disagree, Mr. Paris, we do have the manpower... it's called community responsibility! Be it individually or by our sheriff's deputies and police officers doing walkthroughs in our local stores as a deterrent to those who do not adhere to local mask-wearing rules, much like having officers sit in their patrol cars on the side of the road is a deterrent for potential speeders. We know all violators will not be deterred, but in contrast, even if just one mask violator is stopped, that has the potential of savings hundreds of lives.

It is disappointing and disheartening to realize that many residents do not have the wherewithal to do the right thing on their own and adhere to wearing a mask, therefore, additional mask mandates and officers patrolling our stores as a deterrent may in fact be a requirement. Whether or not you believe in the virus or the protection masks provide one another, sometimes one has to step up and do the right thing for the sake of others, even if that means you might be inconvenienced a little bit in the process.

We all need to be a role model of "community" responsibility. What have we got to lose except perhaps more loss of businesses, more loss of employment and more loss of lives?

"It is what it is --COVID-19 affects virtually no one," says the President of the United States as over 213,000 Americans so far have fallen victim to this virus and died. Let's hope the next victim isn't one of you or one of your loved ones simply because putting on a mask while shopping indoors and practicing social distancing was just too much of a nuisance for you or a threat to your selfindulgent beliefs.

and basal bark. Cut stump will require a saw for you to cut the plant down to just a couple of inches above ground level. Then apply the triclopyr or glyphosate at a strong concentration using a brush on directly onto the tree where the stump is exposed. It may be beneficial to include a dye spray indicator so that you can tell which stumps have been treated. Basal bark means using triclopyr ester at the base of the plant, spraying the herbicide in a ring on the base. Herbicide treatments work well with controlling privet, but they can still be time consuming. Whenever applying any kind of pesticide always read and follow the label instructions.
