the growing environmental anything, all while potentially problem fostered by plastic bottles and bags.

The Firewise Program, said Riley, is an international program that promotes fire safety around the home.

'Fire (prevention) is just simple stuff like our ancestors did," said Riley. "You can't have leaves under your deck, you can't have leaves on your roof when you have a big fire danger in the community.

"Most homes in these communities like Gatlinburg (Tennessee) were destroyed by ember showers. Flaming embers come off the mountain, dropping on top of the houses and catching them on fire. So, we promote using common sense.

The Firewise Program helps entire communities as well as individual homeowners to clear brush, leaves and other detritus away from close proximity to residential structures.

'Since we've started in Towns County ... we've cut our wildfire costs 75 percent," said Riley. "We're now working in Union County with Mickey Cummings and Diane Woodruff.'

The Firewise Program does not cost the homeowner saving a homeowner everything.

Paris thanked Riley for his presentation and urged Union County homeowners to take advantage of the Firewise Program for their own safety and peace of mind. Due to the drop in humidity this time of year, the risk of fire escalates exponentially.

Union County has been working with the Blue Ridge Mountain EMC to get a fiber optic line up to Neels Gap at the top of Blood Mountain from above Vogel State Park, said Paris in his Oct. 18 meeting.

Since the Gainesville Highway is Union County's primary avenue for additional medical services, the Georgia Department of Transportation installed cameras and a weather station at Neels Gap to help the county monitor road conditions in the winter.

This amendment would remove the requirement that county and city school districts within a single county agree before calling an ESPLOST referendum. This wouldn't apply here, but it would in larger Georgia counties with multiple school systems.

In addition to the amendments, the 2018 General Election Ballot also contains two proposed statewide referenda.

The first referendum provides for a homestead exemption "for residents of certain municipal corporations," which basically means that City of Atlanta residents could qualify for a new tax break.

The second proposed statewide referendum provides a tax exemption "for certain homes for the mentally disabled," and would essentially guarantee that an existing tax exemption for nonprofit homes could still be applied even if a business helped to build or renovate such a home.

only people who went without water for a short while were the few residents on Woodside Drive, though the Boiled Water Advisory would need to stay in place systemwide until the water could be tested for contaminants.

"Boiled Water Advisories are issued when an event has occurred allowing the possibility for the water distribution system to become biologically contaminated," per Health Department information. "An advisory does not mean that the water is contaminated, but rather that it could be contaminated.

'Because the water quality is unknown, food service establishment operators should assume the water is unsafe to drink or use and take the appropriate precautions."

Several food service establishments around town were affected by the Boiled Water Advisory, including Chick-Fil-A, which remained open to drivethrough customers but closed its dining room to conserve water during the advisory.

The deli department at Ingles was also affected by the advisory, as employees were required to wash equipment used to prepare food with water from gallon jugs, and customers were unable to purchase fountain drinks.

Test results for potential water contaminants came back negative on Oct. 19, and Blairsville City Water lifted the Boiled Water Advisory around 9 a.m. that Friday.

In the past, both city and county officials have urged residents to sign up for UCWENS, the wireless emergency notification system that allowed Blairsville City Water to quickly share word of its water leak last week.

The benefit of signing up for the alert system is that residents will know right away via text messages, emails and phone calls any time an advisory is put into place.

People can also receive targeted alerts through UCWENS based on their physical address, as some emergency notifications might only apply to certain parts
