having grown up knowing Carol and Bob, and being able to look to them as "an example for so many different things in helping people and making life better for everyone," has been a blessing in his life.

"It did not matter if it was church related, community related, bank related, family related, or just watching the two of them in love interact, we have all been blessed to have known them, and to have been a small part of their lives was an honor for me. They will be so very much missed," said Paris.

United Community Bank President Andy Williams, who knew Bob and Carol both professionally and personally, agreed with Paris that - first with Bob, and now with Carol - the community has lost a tremendous pair of gracious leaders

Williams called Carol a "woman of strong spirit," adding that "if you wanted to know how Carol felt about an issue, you'd just ask her."

You didn't see Bob without Carol being very close

by," said Williams. "In the true sense of the word, she was a true helpmate for Bob Head, and he would tell you that if he were here today.'

Added Williams: "Bob was a mentor to many, many people. We'll never know the number of people that would drop by Bob's office for advice, for directions on

Union County voters will also be asked to support or reject the continuation of the county SPLOST in the Nov. 6 General Election.

A SPLOST (Special Purpose Local Option Sales Tax) is a 1-cent sales tax that is collected by counties for up to six years for the purposes of funding county and city capital outlay projects such as roads, public safety, infrastructure,

The sales tax in Union County is 7 cents on the dollar, which includes a penny for current SPLOST IV collections.

Since the county is already collecting SPLOST money, if residents decide to renew the SPLOST, the sales tax rate within the county will stay the same at 7 percent.

SPLOST V is expected to collect \$24 million over its six-year collection period, just like SPLOST IV.

The county would also be able to issue \$10 million in SPLOST-backed bonds to complete projects if the

referendum passes. Also on the ballot are five Proposed Constitutional

issued by the Department of Amendments, including: the creation of the Georgia Outdoor Stewardship Trust Fund to protect water quality, wildlife habitats and parks; the creation of a statewide business court to lower costs, enhance efficiency and promote predictable judicial outcomes; the encouragement of the conservation, sustainability and longevity of Georgia's working forests through tax sub-classification and grants; the provision of rights for victims of crime in the judicial process; and the authorization

of fair allocation of sales tax proceeds to county and city school districts.

Further, there will be two Proposed Statewide Referenda on the ballot, one providing for a homestead exemption for residents of certain municipal corporations, and another providing a tax exemption for certain homes for the mentally disabled.

Of course, voters will want to more fully familiarize themselves with the language of the amendments and referenda before voting.
