Constitution as a Legal Document

We often times refer to the founders, framers, and ratifiers as our early American Patriots, but today we want to recognize a modern-day patriot during this reflection.

Outspoken Conservative Supreme Court Justice Antonin Scalia recently stood before an audience at Santa Clara University in California, and unleashed a scathing criticism of the current judges on the Supreme Court. In justification of his criticism he renounced the notion that the Constitution is a living document, subject to the whims of whichever justices happen to be minding the Court. His assertion is tha it is a legal document, and "it means what it says, and it does not mean what it doesn't say." He questioned whether the American people would have ever supported the constitution if they had been told that "the meaning of this document shall be whatever a majority of the Supreme Court says it is. In his long rant against the current state of the court, he predicted that it would bring about no less than the "destruction of our democratic system. I cannot imagine the system can continue with more and more of the basic rules made by the Supreme Court." Just think about what we're hearing. This is one of the most powerful men in the country telling us that the institution to which he belongs is broken. And we would be foolish not to listen.
