No one was thought to be at the business when the fire started sometime overnight, and though Union County Fire Chief David Dyer said his department is still investigating the commercial fire's origin, no foul play is suspected at this time.

Firefighters responded to the scene shortly after 2 a.m. that Thursday following a call from a passerby alerting 911 to smoke and flames coming out of the dry cleaners, Dyer said.

## Folds facing over a dozen charges in Nov. 19 high-speed chase

Justin Ursel Folds led law enforcement on a dangerous high-speed chase through Union County on Tuesday, Nov. 19.

Folds, 25, has been charged with a number of crimes stemming from his 9-mile flight north into Blairsville, according to the Union County Sheriff's Office

His local charges include possession of methamphetamine; tampering with evidence for throwing items out his vehicle window; theft by receiving stolen property for driving a reportedly stolen elude law enforcement.

The Georgia State Patrol has charged Folds with possession of drug-related objects; driving while under the influence of a controlled substance; driving with a suspended or revoked license; reckless driving; obstruction of law enforcement;

speeding; littering; four counts failure to maintain lane; five

car; and fleeing or attempting to counts driving on the wrong side of the roadway; and driving the wrong way in a one-way rotary traffic island.

Folds was arrested Tuesday when the chase came to a safe conclusion around 5:30 p.m. in the dead-end alley behind the Seasons Inn Motel in Downtown Blairsville.
