gap between them, though an exterior wall covers the gap from public view.

The front entrance area of the business located in the adjacent connected building suffered heat and smoke damage, while the fire had no discernible impact on the second building's basement.

Firefighters remained on scene for several hours and even returned twice that morning to extinguish flames that flared back up from smoldering debris buried within the collapsed half of the business.

First responders reached out to business owners Chris and Mary Spry after fighting back the fire, and the couple arrived at their burned building Chris right away and Mary after taking their children to school – in utter shock.

The Sprys have been in contact with their insurance company about next steps for their business, to include how to go about rebuilding, purchasing new equipment, and cleaning/ replacing customer items that were inside the business at the time of the fire.

Mary Spry said they have every intent of returning to business as soon as possible, but they're still working out what they need to do and how long it will take because they've never been through a situation

And while the couple does have a clothing dropoff/pickup location in Hiawassee, the Blairsville location was where all the actual dry cleaning took place for the business, meaning the Sprys and their employees have lost their source of income for the time being.

We're just sitting here going, where do we go next, what do we do next?" Mary Spry said. "We both worked in the cleaners, so we had no other income. So, we're worried about our own family and the families who worked for us and just wondering how everybody's going to make it.

"And we're also worried about the people who had items in the cleaners that got destroyed, worrying about how we're going to deal with this with the insurance company on getting those people reimbursed for those items.

Spry said the family will be updating customers on the status of their clothing pending direction from their insurance company on how to move forward with salvaging/replacing items or reimbursement.

Jan Teague of Blairsville has started a "Spry Family Dry Cleaners Fire Fund" on GoFundMe.com, and people looking to assist the family

should be sure to visit the fundraiser online.

"The Spry family are some of the hardest working, kind-hearted folks you'll ever meet," Teague said. "They took a dream and made it into reality and have become a staple of Blairsville, carrying on the traditions of their predecessor

"They poured their hearts, blood, sweat and tears the past few years into gaining the confidence and trust of this community. They are an important part of our small businesses here.

"And though insurance may cover the loss, it won't cover the dream they lost. It doesn't keep a roof over their heads. They are the only dry cleaners in our town, and we need them! Please help us help our friends and family, The Sprys."

Mary said she and Chris were extremely grateful for the outpouring of public support during their family's difficult time, and that the Sprys were looking forward to getting back on their feet.

'We have no plan of quitting. We want to rebuild or get another building, whatever we have to do to re-open the business," Spry said. "We want to say thank you to everybody for all their support and all their help.


"Please bear with us – we are going to get everybody taken care of for their items that are in there as soon as we can, we just have to wait on the process that we have to go through with the insurance.'

The Sprys have operated their business for about four years out of that building, which formerly housed Harbin Dry Cleaners for decades.
