

Volleyball: Pace Academy ends Union County's season in Final 4

Union County Volleyball's postseason run came to a close Saturday in the Class AA/A Final Four with a 3-0 road loss to an uber-talented Pace Academy squad.

"[Pace] is definitely on a different level," Union County head coach Anna Chapman said. "Going in, we knew it would be a tough battle, but we wanted to give it our best shot."

On Wednesday, Oct. 28, the Panthers traveled to Augusta and knocked off Davidson Fine Arts - the champion from Area 2 - in the State Elite 8. Union County took the first two sets before dropping the third. In the fourth and final set, the Panthers pulled away 25-19 to secure the 3-1 victory.


The Panthers never trailed in a 25-21 first-set victory, despite Davidson's repeated comeback bids. The home team evened the score at 9-9 and stayed within a point as late as 15-14 before Union began inching away with leads of 21-16, 22-17, 23-18 and 24-19.

The Panthers faced their first deficit of the match in set two, trailing 4-2 before storming ahead 11-7. However, Davidson had a run of its own, eventually jumping in front at 14-12. But in the end, Union dropped the hammer, outscoring the home team 13-4 down the stretch to take a 25-18 victory.

Union's set-three struggles continued as Davidson led wire-to-wire in a 25-16 win to pull within 2-1 overall.

"I think we have a bad habit of playing down to our competition," Chapman said. "After watching [Davidson] warm up, we thought it would be an easy win, so I think we took them lightly. It reminded me of the match with [Atlanta Classical Academy] in the first round.'

The Panthers finally had enough, taking four of the next five points to punch their ticket to the program's first Final 4.

Tournament. Union's 29 total points also marks the most Pace has allowed in a match.

"I think we were really shell-shocked after that first set and I was afraid we wouldn't put up much of fight the rest of the way," Chapman said. "So I told the girls after the first set, 'we got six points, let's try to get more this set.' I continued to remind the girls that between each set, and we got 10 in the second set and 13 in the third."

Pace Academy will face Class A public school Gordon Lee for the State Championship. For whatever reason, the Class A split between public and private doesn't apply to volleyball at the AA level. While Class A Private

schools were not included. Even though the split was instituted to prevent small Class A public schools from competing against private schools, it appears the GHSA overlooked the sport of volleyball since Gordon Lee's reward for reaching the State finals is a matchup with a private school from a higher classification.

Meanwhile, the Panthers should enter 2021 with a topfive ranking and will be the heavy favorites to repeat as Area 8 champions.


Throughout much of 2020, Coach Chapman leaned heavily upon a nine-player rotation that included only one senior. Those eight underclassmen featured five juniors, two take them up on it." sophomores and one freshman.

And with the likelihood of state championship level expectations entering next year, Chapman hopes to beef up the schedule and even hinted at the possibility of visiting Pace Academy in the regular season.

"After [the Pace Academy match], I started thinking how it's such a disadvantage to come up against a team that good for the first time in the final four," she said. "Next season, it would be helpful if I scheduled matches against teams like that. I think if we had seen a few teams on that level, we would've been better prepared. But [the Pace coaches] were really nice and invited us back to play them next season, and I might just

Cross Country: Union qualifies for State, falls short of Region title Gambrell and Gregory turn in runner-up performances at Region meet

Helen - Both Union County Cross Country teams qualified for Saturday's State meet with a pair of top-three finishes at the Region 8-AA meet on Wednesday, Oct. 28.

Previously slated for Thursday, Oct. 29, the threat of tropical storm conditions moved the race to Wednesday.

Hosted by Unicoi State Park in Helen, the region meet saw Union's Luke Gambrell lead the Panthers to a secondplace finish with a runner-up individual performance. The senior clocked in at 17 minutes, 37 seconds, but it wasn't enough to catch Region Champion Buck Ledford of Banks County, who pulled away from the field with a time of 16:41.

Banks County would take the team title with 23 points - 11 points better than Union County.

Junior Hunter Hartzog placed fifth with a time of 18:02; senior Hunter Payne was seventh at 18:37 and freshman Zander Rotko was eighth at 18:52
