Arby's Restaurant expected to be greenlit in corporate meeting Dec. 16

Pending corporate approval by Arby's, developer GLM Development has tentatively agreed to purchase land for the restaurant from the Blairsville Downtown Development Authority for

The announcement came in a Nov. 19 called meeting of the DDA Board at City Hall, exactly one day after the expiration of the developer's third 30-day contract extension.

Ultimately, the DDA Board granted a fourth contract extension dated retroactively to cover the Nov. 18 "dropdead date" from the previous extension to allow the developer to present the purchase proposal in the next Arby's corporate board meeting on Dec. 16.

State Rep. Jay Powell remembered for 'benevolent spirit'



YOUNG HARRIS -District 171 State Rep. Jay Powell, 67, passed away during a legislative leaders' retreat at Brasstown Valley Resort on Tuesday, Nov. 26.

The Towns County Sheriff's Office requested assistance from the Georgia Bureau of Investigation, though no foul play was suspected in his death, according to the

Georgia House Speaker David Ralston released a statement last week discussing his friend and Republican colleague, who has been an influential state politician since his initial swearing into office on Jan. 12, 2009.

"It is with profound sadness and a broken heart that I write to inform you of the passing of our colleague, dear friend and brother Jay Powell," Ralston said. "Jay collapsed last night at a Caucus leadership retreat and, from all indications, passed immediately.

Funeral services for Powell were held on Sunday, Dec. 1, in his hometown of

According to his obituary, "Jay had a long and distinguished career as a public servant. He served as Mayor of Camilla from 1996 until 2007. He was elected to the Georgia House of Representatives in 2008, where he served until

"Powell represented House District 171, which includes Mitchell County and portions of Colquitt and Decatur counties. As Chairman of the House Rules Committee, Jay oversaw the flow of legislation and determined what bills should be debated and voted on the House floor. See Powell, Page 2A

Federal judge denies Mike Gowder's request for new criminal trial

Last week, a federal judge denied Mike Gowder's request for a new trial following the former hospital CEO's Oct. 24 conviction of more than 100 counts involving dozens of illegal prescriptions.

U.S. District Judge Richard W. Story issued his Nov. 26 denial in response to a motion filed by Gowder's attorney, Stephen Sadow, on Oct. 28, just four days after a federal jury returned a 102count guilty verdict in the

Gowder and Heaton remain free on bond pending a sentencing hearing, which will take place following a sentencing investigation that could take several months to

Former co-defendant in the case David Gowder, who is Mike's brother, pleaded guilty in March to one count of prescribing oxycodone without a legitimate medical purpose. David also remains free on bond as he awaits sentencing.
