"This is really attributed to every employee who works here," said Superintendent John Hill in the Nov. 19 regular board meeting. "We're really proud of that and very thankful. (It's) very humbling, and we're very appreciative of our staff and their hard work.

Four women charged with possessing meth in jail

On Thursday, Dec. 5, the Union County Sheriff's Office Narcotics Division conducted an investigation that resulted in four inmates of the Union County Jail receiving additional charges for drug-related crimes. During the investigation,

an amount of methamphetamine was located inside of a cell in the female pod. Five search warrants were obtained through Union County Magistrate Court for five female inmates for drug-testing purposes.

It was further learned that Lora Ann Deyton smuggled a quantity of methamphetamine into the jail through the use of a bodily cavity and distributed

TCSO deputy shot during traffic stop; suspect at large

YOUNG HARRIS-The Georgia Bureau of Investigation and the Towns County Sheriff's Office are seeking the public's help in locating a man who shot TCSO Deputy Austin Bradburn following an early morning traffic stop Friday.

At press time Monday, Bradburn was still being treated at Northeast Georgia Medical Center in Gainesville for a gunshot wound to the leg that was not considered lifethreatening, and he is expected to recover, according to law enforcement officials.



The whole project was paid for solely by Special Purpose Local Option Sales Tax funds, and the total came out to be about \$2.9 million

According to Parks & Recreation Director Scott Thompson, approximately \$2.8 million covered the architecture and engineering, along with construction, equipment and furniture. The rest is going toward "remaining invoices to be paid (by) smaller amounts.

Those special floors, stage and an impressive sound system are what set this gym apart from its fellows. Additionally, Sonja Leia Morgan, Kaitlyn Brianna Kincaid and Amanda Marie Lester were charged with felony possession of a Schedule II controlled substance in relation to this incident.

Below are the charges for which each of these inmates was previously incarcerated:

Lora Deyton, 36, of Young Harris, was arrested on Dec. 3, two days prior to the jail investigation, for possession with intent to distribute methamphetamine and possession with intent to distribute crack cocaine.

Sonja Morgan, 37, of Murphy, North Carolina, was arrested on Nov. 5 for possession

of methamphetamine. Kaitlyn Kincaid, 28, of Murphy, North Carolina, was arrested on Oct. 18 for aggravated assault, trafficking methamphetamine, trafficking fentanyl, fleeing and attempting to allude officers, driving while license suspended, possession of drug-related objects,

Patton stated that things are moving along "way ahead of schedule," and Hill suggested a potential ribboncutting sometime in April 2025 with the hope that kids could participate and be there when the public tours the building.

"It is stretching our

it's stretching our kids. They're having to think harder, they're having to work harder - that's not a bad thing," Decubellis said, adding that the most difficult aspect of the change has been trying to get students to take assessments online.

That said, there have been successes. Kids are "digging deep" into subjects that are considered above grade level and performing in outstanding ways. Sometimes, that may present as writing more than required on assignments or having deeper conversations with educators.

Decubellis and primary teachers said that, overall, Benchmark has been a good thing to date. The board agreed and discussed renewing the curriculum after its initial three-year subscription during the work session that preceded the regular meeting on Nov. Champions.

Cybertruck driver flees after stop for 'laying drag' Baxter said. "We did pursue him for a

Tesla Cybertrucks are no longer a rare sighting in the North Georgia Mountains, but it's not every day that a fully electric vehicle is seen laying drag in Blairsville. That's what got police to take particular notice of the Cybertruck driven by resident Macon Hill earlier this month.

After 9 p.m. on Thursday, Dec. 5, a patrolling Blairsville Police Officer spotted Hill allegedly driving erratically and spinning his Cybertruck's tires up Bob Head Street, prompting the officer to pull him over in front of Cabin Coffee off the square, BPD Chief Michael "Bear" Baxter said. Once stopped, the officer

made contact with Hill and obtained his information, after which "Mr. Hill decided he would take off," heading south on Cleveland Street and continuing on Gainesville Highway with patrol cars in pursuit, Baxter said. What resulted was a

high-speed chase that exceeded 100 mph at one point; it was nighttime, so traffic was sparse, but in the interest of public safety, Blairsville PD called off onto Town Creek School Road,

Blairsville PD and the Union County Sheriff's Office took Hill into custody, and he was transported to the jail. Georgia State Patrol also responded to the residence,

Baxter said. "We subsequently

according to Baxter. Hill, 42, has been the chase shortly after it turned charged with two felony counts of fleeing or attempting to elude

police officers. He is also facing six misdemeanor charges: DUI - alcohol, less safe; obstructing or hindering law enforcement officers; reckless driving; improper passing; failure to maintain lane; and laying drag.

He bonded out three days after his arrest and is presumed innocent until proven guilty in

As to why Hill fled the scene of his traffic stop, which resulted in numerous additional charges – including two felonies – instead of a couple misdemeanor traffic violations, Chief Baxter said he did not know.

Responding to an area

media Facebook post last week, Hill expressed remorse and apologized for his "mistake," citing recent personal tragedy that led him to cope with alcohol. On fleeing police, he said he was rushing home to care for his dogs "before facing potential legal consequences.'

In a Sept. 11 post on his own Facebook page that appears to have been removed recently, Hill referenced a past prison sentence he received for "(taking) someone's life by drinking and driving." He expressed remorse for that, too, saying that he had yet to forgive himself and was "still crying for the one who passed on.'

The suspect has not been identified but is described as a white man of about 6 feet in height and weighing between 170 and 180 pounds. He was wearing a black beanie, gray hoodie and black athletic pants at the time of the shooting, according to the GBI.

This incident unfolded just after 2 a.m. on Dec. 13 when Deputy Bradburn spotted a silver Honda four-door sedan 2010 or similar model – with no tag, prompting him to initiate a traffic stop on Plott Town Road in Young Harris, near the Union County line.

The driver of the Honda stopped but immediately got out of his vehicle and approached Bradburn. The man did not obey commands given by Bradburn, who then unsuccessfully attempted to tase the suspect, according to

A fight over Bradburn's gun ensued, resulting in Bradburn being shot throughand-through his left leg, after which the suspect drove away in the Honda, leaving Bradburn's gun at the scene.

Towns County EMS and law enforcement responded to the scene and provided care to Bradburn, who was subsequently life-flighted to Northeast Georgia Medical.

A former deputy for the Union County Sheriff's Office, Bradburn swore in as a Towns County Sheriff's Deputy on Oct. 8, according to a Facebook post featuring Sheriff Ken Henderson welcoming his new deputy aboard.

On social media Friday

afternoon, Bradburn shared a graphic image of his gunshot wound and thanked "all my other fellow officers who arrived on scene to administer help and who are looking for the suspect," as well as "everyone who has messaged me to check

He also gave a special shout-out to fellow TCSO Deputy Cameron Adams, whom he described as "not only my partner but my brother

Deputy Adams applied a tourniquet to Bradburn's leg to stem the bleeding while they waited for EMS to arrive following the shooting. Further, Bradburn said Adams traveled to the Gainesville hospital Friday and "stayed by my side even after working all night."

"I will be okay just got some recovering to do,' Bradburn wrote, adding, "If you have any information, follow the instructions below. Please let's get this guy!"
