## Judge Brackett swears in county officials

Union County Probate Judge Dwain Brackett last week swore in most individuals who were elected or re-elected during the November General Election to serve in public offices to start

Now entering his sixth term, Judge Brackett was himself sworn in last week by Enotah Judicial Circuit Chief Superior Court Judge Murphy Miller.

Judge Brackett swore in Mack Mason for his second term as Union County Sheriff, as well as Jason Henson as County

Benny Erwin, who won re-election as County Coroner, will likely be sworn in this week once his paperwork arrives from the Secretary of State's office.

The five remaining recently-elected Union County officials participated in a swearing-in ceremony that occurred inside the Union County Courthouse on Friday, Dec. 23. Administering their

individual oaths of office, Judge Brackett swore in Janna Akins as District 1 Board of Education Member, Cary Cox as Chief Magistrate, Lee Knight as Tax Commissioner, Cindy Odom as District 3 Board of Education Member, Judy Odom as Superior Court Clerk and Lamar Paris as Sole Commissioner.

The ceremony set a positive tone for the upcoming year – the oaths were taken seriously, and everyone seemed excited to embrace whatever challenges 2017 has in store.

#### Manmade wildfires highlight need for caution Highway was reopened. The

The Appalachian Trail was closed from Neel's Gap to Tesnatee Gap, a result of a wildfire started by a car crash two miles south of Neel's Gap,

according to the U.S. Forest The wildfire was one

of two started by car crashes. The first fire began on Richard Russell Scenic Highway (Georgia 348) on Dec. 23, according to USFS.

Approximately 435

acres, mostly leaves and underbrush, were burned. Union County Fire Department fought to contain the blaze along with USFS.

As of Christmas Eve, the Richard Russell fire was contained per U.S. Forest Service and Richard Russell

fire on 129 South in Lumpkin County is being assessed, and Forest Services officials as well as Lumpkin County Fire are on scene. UCFD had not been requested for assistance. There were no homes

or structures in danger at press time. The Appalachian Trail from Neel's Gap to Tesnatee Gap was closed. On Dec. 23, wildland firefighting crews responded to the "Bad Santa Fire"

burning along the Russell-Brasstown Scenic Byway (Hwy 348) north of Tesnatee Gap. That fire, approximately 435 acres with very slow rate of spread, was contained. A section of the highway that was closed Friday has reopened, though travelers have been urged to use great caution and avoid the area altogether if possible.

The Swains Cove Fire, off U.S. 129, a couple miles south of Neel's Gap, posed



## **2016**, a year to remember, Part 1

At the close of each year, the North Georgia News recaps some of the biggest stories to hit the front pages of this newspaper over the course of the year.

Considering the scope of the most important news in 2016, this report will be part one of a two-part article concerning the

goings-on of the outgoing year. While the latter half of 2016 was consumed with news of wildfires and drought, the year opened with a torrent of rain that

began in late December 2015. Firefighters with the Union County Fire Department were rescuing residents from

flash flooding that occurred on Christmas Eve 2015, and the stormy weather continued into

Ultimately, Union County became part of the federal disaster declaration for the period of storms that raged between Dec. 22, 2015, and Jan. 13, 2016, making the county eligible for both federal and state disaster aid reimbursements for road/ culvert damage, debris cleanup, the use of emergency protective services and repairs for riverbank damages in recreational areas.

After all the paperwork had been filed and finalized between March and September. along with a roughly \$20,000
