said. "It is the responsibility and duty of the tax commissioner to collect all the taxes and distribute them back to the appropriate authorities. The county and school board have set their budgets expecting this money to meet requirements for maintenance and operations.'

Commissioner Knight said the Tax Office also is working on an online web service to search, view, and pay property taxes.

"This is expected to be up and running in the next

couple of months," Knight said. "The taxpayers will be able to go online and pay their property tax bill and see how much they owe and if the taxes have been paid.

"This will help landowners with a mortgage escrow account for property taxes to see if their taxes have been paid," Knight said. "This will also provide transparency in public records of who has or has not paid their property taxes.

Commissioner Knight said his first year in office has been a smooth one.

"This has been a good first year and I have really enjoyed the job," he said. "There are a lot of great people here in Union County and I appreciate the opportunity to serve as your tax commis-

"We want everyone coming into this office to receive professional, courteous and reliable service," he said.
