federal prison for Hill. Hill still faces a state court indictment for two counts of violating the Georgia Racketeer Influenced and Corrupt Organizations Act (RICO), four counts of subornation of false swearing, and one count of attempt to

commit subornation of false swearing, state court records show.

Hill filed a motion to dismiss the indictment, alleging excessive pre-indictment delay and a violation of his speedy trial rights.

The trial court denied

Hill's motion, and Hill appealed to the Georgia Court of Appeals. In May 2012, the State Court of Appeals agreed with the trial court.

Hill contended that the trial court abused its discretion by denying his claim of pre-indictment delay, because the State delayed the prosecution of his case to gain a tactical advantage, and he sustained actual prejudice as a result, Georgia Court of Appeals records show.

The State Court of Appeals denied Hill's claim in May 2012.

That case continues against Hill, state court records show.
