The Veterans Retraining Assistance Program (VRAP) offers 12 months of retraining assistance to Veterans who are: Unemployed; at least 35 but no more than 60 years old; have an other than dishonorable discharge; not eligible for any other VA education benefit program; not in receipt of VA compensation due to Individual Unemployability; not enrolled in a federal or state job training program; enrolled in a VA approved program of education offered by a community college or technical school.
