"There's nothing more honorable for me than to be able to stand here and thank our veterans, those who have sacrificed their all," said Sen. Gooch. "Some gave their lives, some are still permanently disabled today.

'People who came back from that war weren't welcomed back like they should have been, and we're doing that today. We're welcoming you back home today, and we're thanking you for your service. Men and women all over the world served in that conflict. The people in Union County deserve to be remembered. This bridge will be dedicated in your honor and in your memory, and it will always be remembered for that.'

## Lazaro Oviedo tice, Oviedo, at 5-foot-11,

158 pounds, with black hair and brown eyes, had been last seen in a white, four-door sedan with a sunroof, with an as of yet unknown white male accomplice, Lt. Osborn said.

"On Christmas Eve day, at approximately 12:30 p.m., a black male by the name of Lazaro Oviedo entered the Food Heaven Chevron Station at the Union/Towns County line, along with a white male," said Lt. Osborn. "Lazaro was a former employee there and had been terminated, and felt like he was owed money.

"The white male went in and bought a quart of oil, keeping the female attendant distracted. And while he was distracting her, Oviedo went to the back office and got the key to the safe. He got \$416 out of the safe and went to leave. The attendant attempted to stop him. He wouldn't stop, and he went behind the counter to get his alcohol permit that the county issues.

"She tried to stop him, but he grabbed her arm, pushed her out of the way, and went out the door," Lt. Osborn said.

Warrants were taken on Oviedo for robbery and simple assault, Lt. Osborn said.
