After graduating from Union County High School, I pursued law enforcement training at North Central Georgia Law Enforcement Academy, and the National Narcotic Detector K-9 School. As Sheriff, I am active in the Georgia

Sheriff's Association, which allows me and my staff to learn the new laws and legislation passed and how to enforce those laws. I am Co-Chairman of the Appalachian Drug Task Force, I work closely with the Union County Anti-Drug Coalition, and I serve on the Board of Directors for the Union County 911.

In the past 12 years, my office has been involved with high profile cases that drew national attention and our office received numerous commendations from multiple law enforcement agencies such as the GBI, FBI and ATF. Our conviction rate of criminals who have been arrested is among the highest in the state. The respect for the Union County Sheriff's Office is extremely high both in our county and in our region. My office maintains a

safe, secure jail that is ran efficiently and professionally with personnel who are devoted to their jobs. Our office staff of deputies, investigators, and office personnel are deeply committed to their jobs and they serve you with professionalism and devotion to duty. We work closely and harmoniously with the district attorney's office and the courts to insure those guilty of crimes are brought to justice.

To assist our inmates

to prepare to cycle back into society better than when they came in, I instituted an in-jail GED program with the assistance of trained professional educators.

Additional features of the Fire Safety House is to teach kitchen safety, home heating safety and reporting an emergency.

"We appreciate everyone coming out to join us today," said Station 4 spokesperson David Dyer. "It's been
very hot, there's been a great
crowd and we've had a lot of
fun. We've had a lot of demonstrations, with our fire trucks,
we've simulated a house fire,
we've simulated an incident
where we had to use the Jaws
of Life and we hope we've
done our part to educate the
people that depend on us."

The families that came out took part in ATV rides, watched simulated demonstrations, and enjoy a hamburger and hot dog with all the fixings. It was hot and there was plenty of liquids to keep folks hydrated.

A firefighter boot was place at each dinner table to allow locals to chip in and help raise funds for the volunteer department.

Dyer said the annual event was all about getting to know the many volunteers who dedicate their time to protect public safety interests, including the lives of their friends and neighbors.

The department has 80 volunteers, with 14 of those volunteers located at Station 4.

"I think everything has gone fine today, there are a good number of people out today," Dyer said. "We really appreciate the public support, we appreciate all the support that the public gives us.

"In turn, we're giving them something back today and hopefully, they won't need to see us on a professional basis," Dyer said. "We had a large crowd today, we had enough drinks, enough chips and enough hot dogs and hamburgers to go around. It's always a good feeling to see this much local support."

For the most part, the firefighters are just regular folks with one exception. They've gone through many hours of intensive training to learn how to prevent a disaster in their community. They've dedicated themselves to public service because they want to make a difference in the community where they live.

Dyer said that one of the most important things offered at the Open House event is a tour through the Fire Safety House.

"We had a lot of kids out here today, I think they had a great time in the Fire Safety House," he said. "We smoke up the house and show

them how to crawl out of the house, how smoke detectors work and what not to do if their house were ever on fire."

Dyer praised the stations chefs, who rotated duties as situations occurred that called them away.

"We've had several cooks today because we've had so many things going on," he said. "I think they did a pretty good job."

Dyer said the Fire Station 4 Open House is an annual event.

"We want the public to come see all of our equipment, ask any kind of question and we try to help people out with smoke detectors," he said. "Overall, it's been a great day.

"The biggest part of open house is education,"

Dyer said. "It's teaching people who we are, where we are and gives us a chance to show them what their donations buy. It also gives them a chance to identify with their firefighters up close and in person."

It also gave locals a chance to meet members of the Georgia Forestry Commission up close and in person.
"We do a lot of work

with the fire department," GFC Ranger Tony Harkins said. "One of the main things we like to promote is our Firewise Program. Firewise communities help us, they help the fire department too. It's about educating communities about what they can do to prevent their communities from becoming victims in the event of a wildfire."
