ditional recreation opportunities in Union County for residents and visitors. The project far exceeded Commissioner Paris' expectations.

"There was a time where that road was full of potholes and trees had grown over into it," he said. "I knew

they had been working but didn't have any idea that it would look that good. But I see this as another quality of life issue. This is another way to enjoy the outdoors in Union County, which is what a large part of our population comes here for. It's especially going

to help those on this end of the county who have a little bit longer drive to Meeks Park. I look at this as just another way to improve recreation in the county.'

In a statement released last week, the TVA said, "as stewards of the Tennessee River Valley, the TVA strives to protect, enhance and improve 293,000 acres of public lands and 11,000 miles of shoreline to achieve the greatest public benefit by working with valued partners, such as Union County.

After getting his first look at the scenic terrain north of Nottely Dam in three years, Commissioner Paris assured TVA Project Leader Kemmy Garrett that the county, with the help of a crew from the Colwell Detention Center, would immediately begin clearing the underbrush and would have the recreation site open to the public in under a month.

"We're aiming for 30 days or less," Commissioner Paris said. "I'm big into recreation and I don't think you can ever have too much of it whether it's for the adults or the kids. We've had an asset like this in our county that for years we were unable to show off and now all of a sudden we will be able to. This is an opportunity where you can canoe


Information recovered during the investigation revealed the property from the vacation home burglary was in a storage unit. All items were recovered, Sgt. Osborn said.
