'We're almost there, almost ready to launch Grandaddy Mimm's Authentic Corn Whiskey," Tommy Townsend said. "It's been a busy summer, but, it's been a good summer.

"Being able to be here in Blairsville and spend time with family and friends means the world to me," he said.

"I've been blessed my lifetime," he said.

On Jan. 25, Townsend announced his partnership with Georgia Distilling Company Inc. in Milledgeville to recreate and market his grandfather's original moonshine recipes legally for the first time. Dubbed Grandaddy Mimms

Authentic Corn Whis key, and Peach and Apple these mountain brandies, spirits will be produced or stills using the Jack McClure design, and built in Georgia using his secret family recipe

originated in Towns County. The back label on the whiskey bottle urges those who partake of the spirits to "drink responsibly and don" forget to tithe on Sunday."

McClure's moonshine recipe had been stored away in the family's memory for more than 40 years. Moonshine is legal today, jus

energy costs to support the economic security of Georgia families.

The final question asks if the state should reduce the sales tax on Made in Georgia products to help support the growth of small businesses in Georgia.

The Republican ballot includes the same local races as the nonpartisan and Democratic ballots.

At the state level, the GOP ballot pits Incumbent Chuck Eaton against challenger Matt Reid for Public Service Commissioner. Also on the PSC ballot, Incumbent Stan Wise faces the challenge of Pam Davidson.

Also on the Republican Ballot, in the 9th District Congressional Race, Roger Fitzpatrick, Doug Collins and Martha Zoller hope to earn 50 percent of the Primary vote to avoid a runoff.

candidates are The seeking to fill the redistricted 9th District seat.

Straw poll questions on the GOP ballot include whether Georgia should have casino gambling with funds going to education.

Also, voters are asked whether they want to end unlimited gifts from lobbyists to state lawmakers by imposing a \$100 cap on gifts.

The GOP straw poll also asks if active duty personnel

under the age of 21 should be allowed to obtain a Georgia weapons license.

That's followed by the question of whether citizens who wish to vote in a primary election be required to register by their party affiliation at least 30 days prior to the primary election.

Finally, the GOP ballot asks if the Georgia Constitution be amended to provide that the paramount right to life is vested in each innocent from his or her earliest biological beginning without regard to age, race, sex, health, function, or condition of dependency. person Democrats, One Republicans or Independents won't be casting ballots for this election year, actually, for the first time in 44 years, is retiring Tax Commissioner J.W. Payne. Payne has called it a career, with the end of his final fouryeartermcominginDecember. Payne, a life-long Democrat, decided not to qualify for reelection because of pending health issues. Authorities say Debra J. Brown, 50, talked her way through the incident, convinced her husband that the two would get back together, and convinced Ronnie Dale Brown to take her back to her

When they arrived back at Debra Brown's car, both got into Debra Brown's vehicle.

The couple then traveled to Debra Brown's parents house; Ronnie Dale Brown brought the gun along, authorities said.

Authorities say Debra Brown went into the home, told her folks to call 911 and went out the back door.

The 911 call came from 169 C.H. Colwell Drive, the home of Debra Brown's parents, Union County sheriff's authorities said. Union County sheriff's

Deputy Travis Gibson soon arrived and began questioning Ronnie Dale Brown as he stood outside.

"Deputy Gibson asked him if he had a gun," sheriff's Investigator Lamar Dyer said. "He said he had no gun, but Deputy Gibson could see it in the front seat. It was a 12 gauge sawed off shotgun.'

Sheriff's Cpl. Julio Cruz and Sgt. David Goodwin also arrived at the scene to assist in the arrest, Investigator Dyer said.

The first charge against Ronnie Dale Brown was misdemeanor obstruction for lying about not having a weapon, Investigator Dyer said.

Other charges against Ronnie Dale Brown followed after investigators had the opportunity to interview Debra J. Brown and her parents, Investigator Dyer said.

Those charges include kidnapping, false imprisonment, possession of an illegal sawed off shotgun, possession of a weapon during the commission of a felony, and aggravated assault, Union County arrest warrants show.
