ily involved with this rating

system. The more equipment

required to lower the ISO ratings, the more equipment that will be sold. Q. Why do you think

the system is unfair to Union County?

A. The main ISO ratings are based on the fire department being able to reach a home within five miles receiving a lower ISO rating. In a rural county, especially ours, with full-time firemen, we can reach a location six, seven or eight miles out often in the same time a city fire engine could only travel five miles, but yet we both have the same requirements. We have less traffic, less traffic lights and don't have parallel parking on or beside county roads to create additional obstacles. No credit is given for the fewer number of fires occurring in our county as compared to other similar counties. No

E-fairness is about closing a tax loophole, not creating a new tax.

The online sales tax loophole is hurting small businesses across America. E-fairness legislation would give states the ability to enforce their existing state and local sales and use tax laws on online-only retailers in a manner that does not infringe on or overly burden e-commerce.

legislation E-fairness could actually help lower tax-

Many conservative governors have spoken out recently about their states' own budget shortfalls. They have mentioned e-fairness legislation as an effective way to enforce existing tax laws rather than raising taxes in other areas.

E-fairness is not a tax on

Businesses don't pay sales tax; consumers do. The MFA or MEA doesn't create a tax for online-only businesses; it simply allows states to require them to follow the same rules as their brick-and-mortar counterparts

Secondly this legislation will actually strengthen State Rights – something that is solely needed given the ongoing federal power grabs through Executive orders and bureaucratic federal agencies. Again here are the facts.

Federal e-fairness legislation would empower states.

The MFA or MEA would help states enforce their own existing sales tax laws on out-ofstate, online-only retailers, giving states more authority over their own fiscal matters. Additionally, it would not impact intrastate sales.

E-fairness would help states cut taxes or forego future increases.

Passing e-fairness legislation would empower states to

close their budget gaps by collecting taxes that are already due, rather than forcing states to increase taxes to meet their shortfalls. Furthermore, some governors have indicated their support for cutting corporate and individual taxes once this loophole has been closed.

E-fairness is not a national mandate for states.

Instead, it simply gives states the option to decide whether or not to require online-only retailers selling within their borders to collect and remit sales their own sales tax.

Third much of the opposition is being ginned up by EBay under the guise of protecting small business. In response to the growing momentum behind e-fairness legislation to address this problem, eBay has now come out against the Marketplace Fairness Act. In doing so, they claim their sellers are wholly opposed to this impor-

tant legislation. Finally, as the facts become widely known, more and more conservatives at the State and Federal level are supporting this much needed legislation including Governor Deal. www.standwithmainstream.com for quotes from

other prominent conservatives. So I have personally contacted our Congressman Doug Collins' and Senators Isakson and Chambliss' Washington and District offices to express

my support for this legislation. I would suggest each of you to familiarize yourselves with the facts and then determine if you can support the Marketplace Fairness Act. Whatever you decide, let your representative and senators know where you stand so that they can make a well-informed vote that is in the best interests of the majority of constituents they represent.

Q. Is the Fire Department funded out of regular tax dollars?

A. No, it is not. It is predominately funded from life insurance premium tax proceeds. Each time you make a purchase or payment on a life insurance policy, a portion of those funds goes to the State of Georgia, which is returned to counties from where the payments originated. Last year the Fire Department's budget was \$935,000 and the insurance premium tax revenue was approximately \$850,000.

Q. You said we have more than 80 volunteer firefighters. How much training are they required to obtain?

A. They are required to obtain a minimum of 95 hours of firefighting training. Any other medical training the volunteer wishes to obtain is on top of the firefighting training. Volunteers are required to obtain 60 hours of firefighting training annually thereafter. This takes a tremendous amount of time and we owe a large debt of gratitude to our volunteers. That is why donations to their individual stations are so important. It insures that the lifesaving equipment they have works properly, is up to date, and is available to save you or a member of your family or friends in an emergency. These gentlemen and ladies are also involved in search and rescue and may be out all night at times for no pay other than a small \$15 stipend to help cover their gas expense.
