felt that given the state of the economy, there were still Union County families that needed that protection afforded by working smoke detectors.

He contacted Wal-Mart Manager Dean Justus and worked out a deal where the county could get a discounted rate on smoke detectors.

On Friday, Justus, Paris and Union County Fire Chief Charles Worden began a joint venture that will assure smoke detectors will be in the homes of families that can't afford them.

"We're initiating a program where we were able to get some financing for smoke detectors," Chief Worden said. "We're going into a partnership with Wal-Mart. Dean has been gracious enough to give us an affordable price."

Anyone in need of a

smoke detector, but, can't afford one, should call (706) 439-6091, Chief Worden said.

"They just need to leave

the proper information and we'll get back to them," he said.

"We will install up to

"We will install up to two in each residence where there is a need."

Those seeking free smoke detectors will be asked to fill out a short questionnaire for information used by the UCFD, Chief Worden said.

"Commissioner Paris asked me how we could get this program going," Chief Worden said. "We've ironed out the details, and hopefully we can do this on a continuing basis."

Chief Worden said smoke detectors save lives

and property.

"It's the first indication that a lot of people have," he said. "At night, especially, smoke rises, the detectors are

put up high in the home and will detect smoke before anyone can actually smell it."

Chirping smoke detectors are not good news. A smoke detector that is chirping needs a new battery or is defective, Chief Worden said.

"If we can get them working, we'll put a new battery in the existing detector, if not, we will replace them," Chief Worden said.

Justus said the partnership is huge to Wal-Mart.

"Wal-Mart appreciates the opportunity to work with Charles (Worden) and the fire department," Justus said. "We want to be a good neighbor. We strive to do that for the community.

"The folks in Union County have been unbelievable and supported Wal-Mart since it was built. We're appreciative of what the county does for us, and in turn, we want to do something for the county," Justus said.

Justus said local agencies need only give him a call and he'll do whatever he can to help.

Commissioner Paris said the help from Wal-Mart means volumes in Union County.

you can define the boundaries of the cemetery.

"You can map the cemetery from that and then you can try to locate descendants to help identify who is in which grave," Paris said.

Mayor Conley said that the Union County Historical Society has a list of the people buried in the cemetery.

"We're hoping that people will get interested in this project," Mayor Conley said. "We're hoping family members will be able to read this story and tell us if they have loved ones buried here."

The next step is for the City of Blairsville to gain title to the property, there is no record of a property owner of the property on the books in Union County.

County.

"There is no ownership recorded of this property,"
Commissioner Paris said. "The city will seek what is called a quiet title."

"That will give us control over what goes on with the cemetery," Mayor Conley said.

Each April, the Sons of Confederate Veterans honor those Confederate veterans who fought in the Civil War during Confederate Memorial Day.

SCV places Confederate flags on Confederate graves in Union County.

This year, when the service was over, a small group of people, Paris and his wife Dinah, White, Regina Allison, and Joseph Adams were present to pay respects.

The group thought so much of the site that they decided it ought to be maintained and claimed by the city and county.

"Lamar (Paris) called me one day and they had a service over at the War Memorial," said Mayor Conley. "So after the service was over, Elmer Hogue, White, and several others had already started a proposal. They're not looking for the city for funds to do any of the work that needs to be done over there. They're looking for the city and county to maintain it after the work is done. The organization is going to raise the funds. I think the city should claim it. It would be an honor to."

White said the Sons of Confederate Veterans has raised \$2,000 for the project.
