### **Not Judged**

I put the jury summons in a prominent place on my desk. I wrote the date on my calendar. I actually looked forward to doing my part for law and order. One Monday morning casually starting the week, I suddenly realized it was today! I had one of those gasping, dash to the car, hope I don't

get a speeding ticket panics.

I slipped into the courtroom embarrassed and tardy by 45 minutes. Soon the judge allowed everyone to leave except the selected jurors, and me. Summoned to the bench I made no excuses and braced myself because

I failed a legal obligation. I did not want to face judgment.

Who does? Judgment usually means someone else decides if your behavior is acceptable. Our post-modern mindset that everyone can have their own values is probably why the most oftquoted Bible phrase is "Judge not lest you be judged," especially by those who heed no other verse.

If it's true that every yearning of the human heart can only be completely fulfilled by God, then the yearning to escape judgment is no different. But effecting such escape cannot come from believing that God cannot be both of love and judgment. Believing something doesn't make it so! So how, then, does God fulfill our yearning to avoid the final gavel?

Jesus has the answer. "He who believes in (the Son) is not judged; he who does not believe has been judged already because he has not believed" (John 3:18). Remarkable! Here it is again: 'He who hears My word, and believes Him who sent Me, has eternal life, and does not come into judgment, but has passed out of death into life." (John 5:24). Faith in Christ means you are not judged the way an unbeliever is. Paul explained further, "He made you alive together with Him, having forgiven us all our transgressions, having canceled out the certificate of debt consisting of decrees against us...having nailed it to the cross" (Col 2:13-14). The indictment against the believer is canceled!

### **Questions and Answers**

Q. If there is a stray cat or dog on my property who should I contact?

A. First and foremost, Do Not Feed the animal. Once you feed it, you are assuming the responsibility for the animal and may be impacting it's decision to stay

or return to its owner or neighborhood. In the case of a feral animal it will stay for the food. If you do not feed it, most likely it will leave in a couple of days. If the animal is injured or otherwise in poor condition. you should contact Animal Control

or the Union County Sheriff's Office at (706) 439-6066.

Q. Does the county have a travel policy for its employees?

A. Yes we do. In January 2015, the County adopted a new Travel Policy that replaced the existing policy entirely and it is derived from the state of Georgia policy. It is fair and easy to understand.

#### Q. What travel expenses are covered when an employee travels for county business or training?

A. If the employee drives their personal vehicle, they are paid according to the Internal Revenue Service standard mileage rates. The rate for 2015 is 57.5 cents per mile. They are also given a per diem of \$28.00 per day for their meals. (This is higher in certain parts of the state.) With this method, tipping servers is the responsibility of the employee and not the county. These are the two main items that are reimbursed since normally we have already reserved and paid for lodging in advance.

Q. How do I know what is on the Agenda for the upcoming County Meeting?

Ă. The Ågenda is posted on the county website www unioncountyga.gov on the Monday prior to the meeting on Thursday. This is a tentative agenda and can be changed in accordance with Georgia's Open Meetings Law prior to the meeting. Normally, there are changes required as new items often come up after the posting. All the previous Agendas and Minutes are posted here as well.

July 6, 2015 and oversees the Welcome Center operations. Sheila was born in Union County and already knows so much about our beautiful area. Like







Reading the boxes on page six about Union County Schools this week brought a few quotes to mind.



this next week event is one of my favorites.

Here's the scoop on this week's Community Flower Show. It's a Union County Farmers Market event, but it is never held at the Farmers Market. The dates this year are August 6-8th and like every year, it is held at the Haralson Memorial Civic Center on Wellborn Dr., Blairsville (next to Steve's Steakhouse and Cookie Jar). By "community flower show", it means that anyone in the community (as well as the contiguous counties in GA and NC) and at any age (kids are encouraged to enter, too) are welcome to exhibit. Entries are accepted Thursday, Aug.6 from 1 p.m.-5 p.m. and Friday August 7th from 9 a.m.-11 a.m. There is no entry fee.

There are a variety of horticultural classes that one can enter, including cut flowers, container/house plants, hanging baskets/containers, bonsai and native plants and shrubs in containers no larger than 16" in diameter. You may enter more than one exhibit. But in only one class or subclass. Containers will be provided for the cut specimens. Please, no cut flower that exceeds 30 inches in length.

Exhibiters must have grown their horticulture and correctly identified the plant material with the common and botanical names on the entry form, but the master gardeners will be there to assist you at registration with all those details, if need be. Plants must have been in exhibitor's possession for at least 90 days (in other words, don't go find your favorite plant at your local nursery and try to enter). They must also be pest free and disease free.

Now, for those of you who love floral design, this category is a little different. This is the only category that must be pre-registered. Please contact Stephanie Gray at (706) 745-3714 to re-See *Leone*, page 5A
