### **Emergency Management Ordinance**

Q. I heard that Fannin County is trying

to pass an ordinance regarding Emergency Management and that there is Lamar strong opposition to the Paris ordinance. Does Union County have an ordinance like this?



A. The Union County ordinance was adopted in 1999 and was a model ordinance provided at the time by Georgia Emergency Management Agency (GEMA) and all counties were asked to adopt it. For some reason, some counties did not adopt it and apparently Fannin was one of those counties. While most parts of the two ordinances are similar, there are a few significant differences.

Q. What is the purpose of the Emergency Management ordinance in the first place?

A. It is put in place to provide for public safety in the event of a tragic event, disaster or major emergency in a county such as tornados, terrorist attacks, severe flooding or any other major event. Each year counties receive a grant from GEMA to assist us in developing and maintaining our emergency management in our county. GEMA has been a very longtime and valuable partner to the counties. At one time this grant was dependent on counties adopting the ordinance.

**Q.** What are the differences in our ordinance and the Fannin County proposed ordi-

A. The Fannin proposed ordinance increases authority given to counties in disaster situations and has some other references that could impact private property rights. However, our ordinance does not contain that language.

**Q.** Is it true that the Association of County Commissioners of Georgia (ACCG) was involved with the new GEMA ordinance

A. I placed a call to ACCG and they gave me the following information. The model ordinance is not anything new. Since 1997, ACCG has worked with GEMA to develop model emergency management ordinances for counties. Beginning in 2010, they also worked with the Georgia Municipal Association (GMA) to develop a comprehensive emergency management ordinance for counties and cities.

Q. Does it impact a county financially if they do not adopt some type of ordinance?

A. Normally it does and that is why ACCG participates in helping GEMA formalize an ordinance. In recent years, the Georgia Emergency Management Agency (GEMA) has

Carolina fired the first shots on Fort Sumter. After this event states across the South held Secessional Conventions to determine whether to stay in the Union or secede from the Union. Alabama held their convention in Mont-

gomery. Wyatt Cummings and the other people of Winston County elected a man by the name of Chris Sheets to represent them at the convention. The people of Winston County were settlers and homesteaders in Winston County. There were only a handful of plantations in the county and most people did not own any slaves. So, in an overwhelming vote the people of the county decided that Chris should vote against secession at the convention. All the people of Winston County wanted was to remain neutral. They empathized with their brothers in the southern part of Alabama. But, the thought of fighting to maintain the right to own slaves was something the people of Winston County didn't understand. During the first day of the successional

convention Chris Sheets was not allowed to speak. When he tried to speak he was thrown into jail and beaten for his stance on the subject of secession. Chris was held in the jail in Montgomery during the entire convention and was only turned loose when the convention ended. He went home battered and bruised as well as feeling he had failed. As you know Alabama did secede from the Union and the War Between the States began. Many of the planters who had vigorously supported secession and war did not want to fight and began paying others to fight in their place during the war. Soon the state created a Home Guard to help protect the interest of the citizens of Alabama. One of the objectives of the Home Guard
