Paris...continued from Page 4A tion, including curbs, sidewalks, and street lights; Parks, recreational areas, facilities, and programs; Storm-water and sewage collection disposal systems; Water utilities; Public housing; Public transportation; Libraries, archives, and arts/sciences programs and facilities; Terminal and dock facilities and parking facilities; Codes, including building, housing, plumbing, and electrical codes; Air quality

control; Planning and zoning. Q. At one of the Public Hearings you read from a long list of mandated and supplemental services the county must and can provide according to state law. Can we get a copy of that document?

A. Yes, we have provided that to you on our county website, www.unioncountyga.gov. On the home page on the left hand side you will see "Recent News" and County Services: Mandated and Discretionary. Or you can come by our office and pick up a copy. There are over 70 different services that counties provide to you, as per Georgia Law.

Q. What elected officials are counties required to have?

A. Counties were created by a rural society that looked to government to keep the records straight and the justice swift. To help counties administer state programs and conduct state courts, the state constitution originally created four elected county officers: the sheriff, the tax commissioner, the clerk of the superior court, and the judge of the probate court.

In 1868 the state began creating the position of county commissioner to administer the general operations of the county. Today every county has a commissioner; many have a board of commissioners (BOC). As part of general county operations, the BOC must finance all county programs and pay the salaries of constitutional officers and their office operation cost.

Q. What powers does the BOC (or Sole Commis-

sioner) have? A. Beyond the powers assigned to the constitutional officers, the commissioner (BOC) is the county governing authority. It has the power to adopt ordinances, resolutions, or regulations relating to county property, county affairs, and the operation of local government. Larger, more urban counties distribute governmental responsibilities among many departments, whereas smaller, more rural counties of 10 employ only a few officials, each of whom serves several

Moving in later years to Florida and Texas, always working outside the home with little time for or interest in great cooking, I was unfamiliar with the va-

riety and great tastes of home grown fruits and vegetables. Mr. D'Angelo's grape vine was the only first-hand knowledge I had ever had of a "home garden." I hate to admit it, but, until moving to Blairsville in the 1990s, I was completely unaware that so many people grew their own vegetables! I had thought Mr. D'Angelo was the last of a dying breed, unable to relinquish the

nary horizons dramatically, not only by allowing me to question the patient growers as to how to cook many of the vegetables and how best to freeze and preserve them, but also by introducing me to vegetables I had never tasted or, in some cases, even heard of. Is this butternut? No, that's acorn. And this... oh, that's a turnip? a love affair with okra. My husband and I tried our hand at a small (tiny) vegetable garden a few years ago and were relatively successful, but not so much so that we rushed to do it again. Now we don't need to. With the rich and colorful bounty available to us each week in the growing season, not to mention the generous and kind advice, I so look forward to going to the market each week and preparing and eating more delicious vegetables than I have eaten in my entire life!

("61 Hours") to have his protagonist, Jack Reacher, inform readers that this drug has been around for a long time. Originally named Pervitin, it was a German refinement of a Japanese discovery: later named Desoxyn.

During World War II, as Major Reacher points out, certain situations and certain operations called for what the field manuals described as altertness, focus, motivation and mental clarity for extended periods. To serve this desired end, methamphetamine was in such widespread use by the

Allies that Reacher makes the laconis comment that he was surprised anyone ever slept during that time. Understandably, the drug was a favorite of bomber pilots on long bombing raids where it was imperative that they stay awake and alert. Not to worry, Reacher assures readers: "They had morphine for sleeping.

Major Reacher makes the unsettling comment that

the demand for Desoxyn was very strong; that it was general issue like boots or ammunition, and that medics carried it in their kits. The method of delivery was up to the medical officers: some made it up into pills, some preferred drinking it dissolved in water, some recommended inhaling it, some preferred it in suppositories. One of the obvious side effects was increased sexual desire.

Perhaps what we are now seeing as the scourge of methamphetamine is the "unintended consequence" resulting from the actions of those who should have known better. We are reaping what we sowed and it is a bumper crop. If the military was largely responsible for the acculturation towards the use of drugs when there is no real physical or mental need, then it owes the American people a huge

security personnel. A license holder who enters or attempts: 209 to enter a government building carrying a weapon where ingress is restricted or screened; 210 by security personnel shall be guilty of a misdemeanor if at least one member of such; 211 security personnel is certified as a peace officer pursuant to Chapter 8 of Title 35; provided; 212 however, that a license holder who immediately exits such building or immediately leaves; 213 such location upon notification of his or her failure to clear security due to the carrying of; 214 a weapon shall not be guilty of violating this subsection or paragraph (1) of subsection (b); 215 of this Code section. A person who is not a license holder and who attempts to enter a; 216 government building carrying a weapon shall be guilty of a misdemeanor.

In that subsection, there is no requirement, no mandating, no obligation, to institute, impose or create "courthouse security.

In that subsection, there is a clear distinction between those who are licensed for concealed carry and those who are not.

Again, \$250,000 worth of "courthouse security" hasn't been forced upon or required of Commissioner Paris by HB 60. To do so was his interpretation of that bill and his decision.

To raise the property tax millage rate to fund that additional cost was also his decision. Has Commissioner Paris

had reason to believe that there is a "risk of courthouse violence?" Let's be sure of where the

responsibility lies for that decision and for its subsequent cost which is certain to increase. - It is government, after all. **George Mitchell**
