# Knight: 'Tax Digest takes a \$461,400 dip'

The 2013 Tax Digest for Union County remains virtually unchanged from a year ago, Tax Commissioner Lee Knight said.

Overall, the tax digest is down \$461,400, Commissioner Knight said.

"Property consolidation and evaluation of the Tax Digest remains practically the same for 2013 as they were last year in 2012 for Union County," Commissioner Knight said. "Total taxable net property values for the school this year are \$1,203,269,963 at the 40 percent assessed value after the Homestead and property exemptions.

"Last year, 2012. the tax digest value was \$1,203,731,363," he said. "That's down \$461,400 in property values for the whole

county of more than \$1 billion of taxable property for Union County property owners."

Property values at the 40 percent assessed values dropped only about 1/20th of one percent for school valuation this year from last year, Commissioner Knight said. "The County taxable property at 40 percent assessed value actually increased slightly in the amount of \$172,000," he said.

The total on the tax digest numbers from last year generated \$19,566,948 for the school and the county in property taxes

If the millage rates remain the same for 2013, the digest numbers would bring in about \$75,537 less in 2013 for both the school system and the county, Commissioner Knight said.

"We are all hoping that the millage rates for the school and the county will not increase this year," Commissioner Knight said. "There are still a lot of folks that are struggling to pay their property taxes.

"Also many people feel that their property is still over valued for the property taxes and what they could get for their house or land in today's

marketplace," he said. "Union County Tax Assessors raised land and home values in 2006 in a re-appraisal of the whole county.

Since that time, land and housing values have declined. That decline started in 2007, and the county has lowered values only about 15 percent.

Because of lower valuations, the Union County School Board unfortunately had to raise the school millage rate at that time, Commissioner Knight said.

"It takes a certain amount of money to maintain all the county and school operations and the money has to come from somewhere,' Commissioner Knight said. "Hopefully we can all continue to be good stewards of the taxpayer's dollar and try

### Sheriff Mason: 'Drug busts to continue'

The Union County Sheriff's Office Narcofics Division continues to make a clean sweep across the county, Sheriff Mack Mason said.

A Union County couple is behind bars following their arrests on drug charges last week.

The arrests of Gary and Sherry Dockery were the culmination of an extended investigation into illegal drug activity, Sheriff Mason said

Gary Dockery, 52, of Dockery Creek Road, was charged with three counts of Violation of Georgia's Controlled Substance Act for manufacturing, distribution, dispensing, sale of a controlled substance.

His wife Sherry Dockery, 48, was charged with distribution of dangerous

drugs, Sheriff Mason said. 'Our investigators seized \$8,630 in cash, a 2000 Toyota pickup, 68 firearms, and a double-wide trailer and two acres of land, Sheriff Mason said. "As I've said before, our goal is to make drug trafficking a very undesirable business

in Union County. Over the last two

weeks, the Sheriff's Office Narcotics Division has seized almost \$17,000 in cash, and more than \$400,000 in property and vehicles following a series of drug busts, Union County Sheriff's Office records show.
