County?
A. I hear this question often and simply try to explain that there are many restaurants in our city and county and they are all very good. Q. When will the Convenience Center open near the Horse Arena for us to take our bagged garbage and recyclables to?

A. There should be an article in this week's NGN about the facility. We chose to do a "soft opening" on Monday, October 29 (last Monday) while we will have the official opening announced in the paper this week. Since it is new, we did not want to have it overwhelmed

with too many customers until the staff and equipment are tested. So it is now open and you are welcome to begin using it. It is located at the intersection of Hwy 515 and Hwy 325, about 8 miles West of Blairsville.

Q. What will be the operation hours of the new Convenience Center?

A. The hours of operation will be the same as that of the current Transfer Station. Mon thru Friday, 7 till 4 and Saturday 7 - 12. This could be adjusted based on usage, but we hope to be able to keep this center busy enough to maintain these hours.

Q. What is the purpose of having a Convenience Center out in the county?

A. As its name implies, it is to make garbage disposal more convenient for the public. We feel this location where we already own the property, will allow a large portion of the county to use it easier than having to drive all the way to Blairsville and then go wait in line with all the cars and commercial vehicles at the Transfer Station. This should be faster and will certainly be cleaner.

to the right as there was a group of motorcycles off to the right at the intersection. My focus was on the crossways car blocking my lane and how I could avoid hitting it. I slammed on the brakes. Smoke, squalling tires, fishtailing and some wrestling with the steering wheel brought the car to a stop just short of the left rear end of car. All traffic on the west bound came to a stop. Had I been a second later, I would have had to either T-Bone the car near its rear end or hit the motorcycle group to the right. Which would you have chosen?

I sat still to compose myself and in 10 -15 seconds, the motorcycles that were to the right in the intersection started across all 4 lanes of 515 and proceed straight ahead. It came to me then, this was their method of crossing the four lanes on 515. Pull out, block and stop traffic on 515 and then cross.

In theory, this might work if they gave the high speed traffic on 515 enough time to react to the crossways car blocking the lane ahead. There simply was not enough time provided in this case. Police and state patrol stop oncoming traffic effectively with blue lights and sometimes uniformed officers clearly waving for you to stop. A car that has stopped in the road and no other indication is not a clear sign that you want all traffic to stop.

It seems to me that if your group is taking control of the 515 Right Of Way, then your group is responsible for making the crossing of 4 lanes safe for your group and all other travelers on 515. Clearly, the crossing of 515 by this group on this day was not done well. Who is responsible for the safety of a group of motorcycles crossing 4 lanes on 515?

focused on driving.
DriveAlert ArriveAlive implores drivers to take responsibility for their driving behavior... buckle up ... just 39% of fatality victims are identified as wearing seatbelts; stay off the phone and no texting ... 74% of fatalities are attributed to driver behavior; drive alert ... do not drive drowsy or under the influence of drugs or alcohol.

While DriveAlert ArriveAlive seeks to reduce crashes through changes in behavior, GDOT continues to use a number of innovative measures that contribute to safer driving - like a safety edge that shapes the pavement edge to enable drivers who drift off the highway to safely return to the road; and rumble strips that help reduce roadway departure by alerting drivers through noise and vibration when their tires make contact. Where there is a high potential for crossover crashes, GDOT installs center median cable barriers. Other safety measures include high friction surface treatments, reflective signage and striping, and pedestrian countdown tim-

ers.

Each morning, the Georgia DOT daily fatality report lists the deaths reported in the past 24 hours on Georgia's roads. It is a somber account. After all, these are not just statistics. They are people whose families are torn apart by tragic loss. That's 138 more people killed on Georgia's roads compared with the same time last year.

You can help turn the tide on preventable crashes and deaths by taking responsibility for your driving behavior. Be the driver you want your kids to be. By setting an example, not only will they be safer when they're in the car with you, but they'll also be safer drivers.

Do it for yourself, for your passengers, for other motorists, pedestrians and bicyclists. Do it for the ones you love!

The Waynesville bypass, Highway 276, was widened, became a heavily-traveled four-lane. The County Sheriff was forced to hire new deputies. So was the Fire Department. Small, local schools closed because of consolidation. Septic tanks became a thing of the past, replaced by sophisticated, but mandatory, centralized filtration systems. Property taxes rose because all those new residents demanded more services.

Many of the "locals," born and raised, couldn't afford to stay. Those who stayed, kept old friends, hesitated to make new. There are no Haywood County "locals" on the school board. Friends who still live there tell me, "The money is good but..." They leave the sentence unfinished.

All I can say is, "Yes, I know."
