The department, as well as the entire nation, has seen a decline in volunteer firefighters. The explanation for this decline is unclear. Regardless the reason, every fire department is in need of volunteers.

The application period for volunteer firefighters is now open, and we are looking for volunteers.

What do you get out of volunteering at the fire department? First, you get valuable training that can save you, your family, and people in your community. The initial training



involves approximately 60 hours of fire ground training where volunteers learn how to safely operate on a fire or emergency scene. From there, the level of certifications and training is limitless. A person may take training in emergency management, emergency medical response, auto extrication, search and rescue, apparatus engineer (pumping the fire truck), and more advanced firefighting.

Second, you get to do things and see things that most people never experience. Volunteer firefighters respond to a multitude of emergency incidents. These incidents can range from car accidents to brush fires to searches. Each incident is different and brings unique challenges that firefighters must overcome.

The best thing about being a volunteer firefighter is that you get to be part of a unique group of people who are dedicated to helping their community. It's a great feeling to know at the end of the day that you, as a volunteer firefighter, were instrumental in helping a person in need. It takes special men and women to make this commitment, which includes training, responding, and being there to help their community. That could be you.

Any person who wants to be a volunteer firefighter can simply fill out an application at the headquarters station. If the person qualifies, the person will be placed in the initial training. After that initial training, volunteer firefighters will be able to respond to emergency calls that they receive on their handheld radio or cell phone

This is not about "Christian nationalism," however it is defined. ## **Commissioner's Questions**

Q. In last week's Q & A, you mentioned county ordinances. What is an ordinance?

A. The Georgia Constitution spells out some basic requirements for local legislation. In order to perform its various functions, Union County Government enacts its own legislation, usually in the form of an ordinance. An ordinance is a permanent rule

of conduct - legislative enactment. An ordinance is equal to a municipal statute, and it governs matters not already covered by federal or state law. Union County may adopt clearly reasonable ordinances, resolutions, or regulations relating to county property, affairs, and government. Union



County may also adopt ordinances to protect and preserve the public health, safety, and welfare in the unincorporated areas of the county so long as they are not "preempted" by the state. Some examples of Union County ordinances address issues such as animal control, short-term rentals, and amplified sound.

#### Q. What is the difference between an ordinance and a resolution?

A. When compared to an Ordinance (which generally provides permanent rules of conduct or government), a resolution usually deals with matters of a special or temporary character. In other words, a Union County ordinance is a legislative act, and a resolution is an expression of opinion or mind or policy temporarily concerning some particular item of business coming to the County's knowledge. Some examples of resolutions passed in Union County include appointing Union County citizens to local Boards, setting election qualifying fees, and declaring local states of emergency, just to name a few.

Q. What is the difference between an ordinance and a proclamation?

A. Whereas an ordinance generally provides permanent rules of conduct or government, a proclamation is not law. Instead, a proclamation is a formal public statement. A proclamation is usually issued honoring an organization, a person or a group, for an achievement or simply as an honor. Additionally, proclamations signify the importance of a community event, significant achievements by community members or to bring atten-

# Watering Plants

All plants, but especially annuals (such as veggies) and freshly planted perennials, are affected by dry soil, because their root systems are not yet large enough to support the plant and do not yet efficiently collect water from surrounding soils. There is a fine balance to be observed when irrigating plants, though: too much water will Watching wash nutrients away and Working from young roots Jacob and may cause rot, while too little or Williams shallow watering will either allow the plant to dehydrate or bring the roots too close to the hot surface of the soil. In general, vegetable plants would rather have more thorough and less frequent watering. When the entire topsoil layer is saturated at least twice a week, the roots of a vegetable plant will tend to grow downward, towards the damper and cooler soil beneath them. Not only will the root system collect water more efficiently, it will also draw the roots away from the drier and hotter surface of the soil. This promotes a healthier plant growth pattern, reducing the need for external watering when there is a rain and lowering the chances of the root system being attacked by unwanted fungi. In the case of other young transplants, such as fruit trees, bushes and shrubs, flowering perennials and other ornamental plants, the amount of water will usually vary due to the soil it was planted in, the size of the original root ball and plant, and the type of plant being watered. For example, a young apple tree from a 3-gallon pot transplanted in clay-based soil will require less frequent watering than a group of raspberry starts in the same soil, due to the higher amount of water loss through the leaves (transpiration) in the raspberry starts. It is always best to check the sticker or plant tag that came with the plant for advice first, but as a general rule of thumb, water trees and ornamental shrubs enough to keep the soil 4 to 6" around the root ball (including below it) moist, but not soggy, every other day that it does not rain. Continue this until they are established. For starts such as blueberries, raspberry and blackberries, hydrangeas, and vining flowers and fruits (like clematis), water 4-6" around the root ball every day it does not rain until they are established in the soil. Common sense applies in this process as well: if the soil around the plant is still about as moist as it should be at day 2, then hold off on watering until it begins to dry again. A good "quick-n-dirty" test for soil moisture is to grab a handful, squeeze it in your hand, and let go. Optimal moisture content is when most of the soil is still in a ball in your hand, but when you touch it, See Williams, page 7A

tion to a county's role in significant events. Union County has issued proclamations to recognize such things as Master Gardner Appreciation Day, the United States Navy Seabees 82nd Birthday, and Child Abuse Prevention Month just to name a few.

#### Q. What does local ordinance violation mean?

A. An ordinance violation is a charge issued by Union County Government for violations of ordinances. In many cases, a person may unknowingly violate a rule because he or she did not even know the activity was illegal. It is important to note that this type of violation is typically processed in the local courts as opposed to the state circuit courts. This means it is not the same as a criminal charge; rather, it is typically civil rather than criminal in nature. However, these violations can still incur fines in addition to other consequences.

Q. What are some examples of ordinance violations?

A. Some examples of lo-

cal ordinance violations are underage drinking, building code violations, noise violations, and animal control violations. A citation for a Union County ordinance violation is not as serious as a misdemeanor or felony charge, but an individual can still face stiff penalties. Violations can result in fines and the loss of a building permit or business license. Under certain circumstances, a violation can be upgraded to a criminal misdemeanor charge. This means the violation could appear on a person's background check.

This typically (of course, depending on the kind of plant) takes anywhere between 3 and 6 weeks from the date of transplant. For trees and shrubs (and blue, black and raspberries, etc.) usually takes most of a growing season to accomplish. For example, if a blueberry bush were set out in early May. it would need this kind of watering until the end of August, and maybe longer depending on the timing of rain or heat.
